The Legislative Audit Bureau (LAB) met with OCI to explain their process for conducting a single financial audit and a program audit. OCI answered questions and responded to LAB requests for information throughout Q1.

A new Deputy Commissioner was appointed, Rachel Cissne Carabell. The previous Deputy Commissioner, Nathan Houdek, was appointed Commissioner.

FEBRUARY

Insurer 2021 Q4 claim reports were due February 14th. The aggregate total for Q4 WIHSP claims was \$185,083,494.55.

OCI, working with Wakely, sent insurers a data call requesting enrollment and premium data to inform the 2023 payment parameter setting process.

OCI finalized the care management/top conditions template and asked insurers to complete it using plan year 2021 data. Insurers will submit completed templates with their final 2021 WIHSP claim forms in May.

OCI resolved an overpayment issue with an insurer who had subrogation recoveries on a few plan year 2020 claims. The carrier flagged that they had received recoveries on those claims at the end of plan year
2021, after the plan year 2020 payments were made. The total overpayment has been calculated and will be deducted from the insurer's plan year 2021 WIHSP payment.

OCI submitted the draft 2021 annual report to CCIIO.
OCI shared the final care management/top conditions template with CCIIO.
Wakely presented various 2023 payment parameter options for OCI's consideration. OCI will determine preliminary payment parameters in April and finalize those in May.
