Thank you for submitting Wisconsin's request for a modification of normal post-award forum procedures. We are requesting additional information on your proposed procedures related to:

- How you will ensure that attendees can ask questions In 2020 we used Zoom and would do that again for 2021, if allowed to hold a virtual forum. Using that platform allows us to both accept questions and comments through the chat feature and allow individuals to unmute themselves to ask questions. This meeting typically yields a manageable number of people and I think we would allow them to unmute themselves. However, another option would be for us to ask attendees to signify through chat that they'd like to ask a question and we could unmute the individuals from our end.
- How you will track attendance Zoom can be set up to capture a list of individuals who join, that is what we did last year. If preferred, we can ask attendees to introduce themselves.
- How you will ensure compliance with applicable federal civil rights requirements and other accessibility requirements (see preamble of 2012 rule) The meeting will be publicly posted to the OCI website and distributed to anyone who is signed up to receive OCI meeting notifications. In addition, the meeting notice is physically posted to the OCI official open meetings bulletin board (in the lobby of the office building), and posted to the Wisconsin Public Meetings, Notices, & Minutes website <u>https://publicmeetings.wi.gov/</u>
