- Automation of the financial and market conduct examination processes through the use of tools such as TeamMate 2000 and ACL;
- Further improvement and enhancement to information available on the OCI Internet site to include:
 - Site index for easier access to information,

 - Quick links to frequently requested pages,
 - Annual and quarterly statements,
 - Application for insurance company licensure information and materials
- Implementation of a pilot project to evaluate the feasibility of having companies file Wisconsin-specific forms electronically over the Internet.

Introduction

Every individual and business in Wisconsin depends upon insurance. Whether it is auto, home, life, or health, insurance plays an important role in people's lives. The Office of the Commissioner of Insurance (OCI) was created by the legislature in 1870 and vested with broad powers to ensure that the insurance industry meets the insurance needs of Wisconsin citizens responsibly and adequately.

The importance of fair, effective, and timely regulation of the insurance industry, as well as continuing efforts toward health care reforms offer OCI a special challenge in meeting its public mission of leading the way in informing and protecting the public and responding to their insurance needs.

The major functions of the office include:

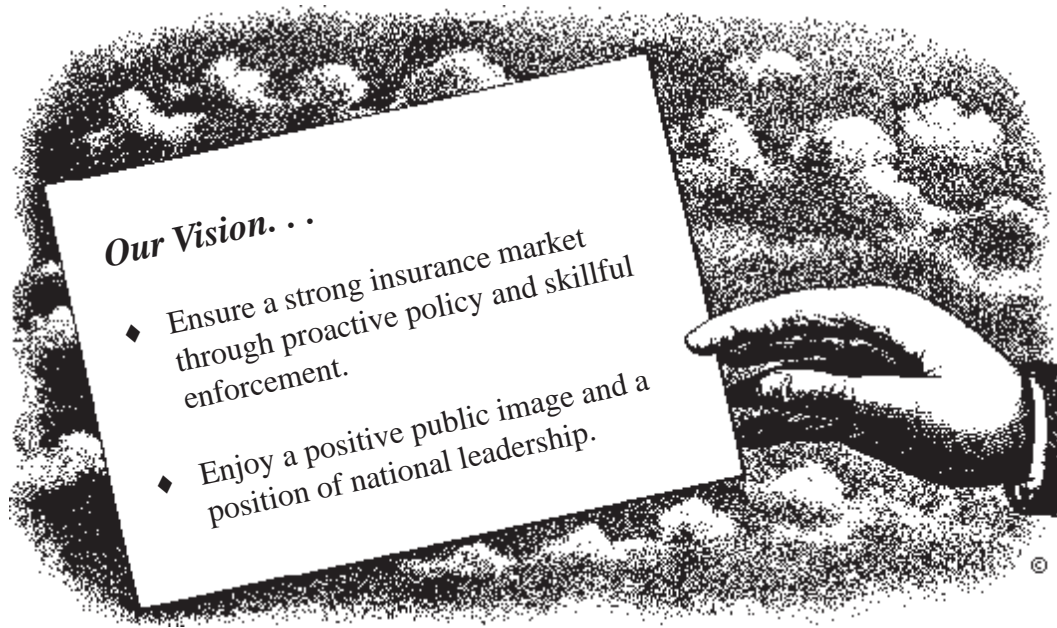
- Reviewing insurance policies that are sold in Wisconsin to determine if they meet the requirements of Wisconsin's laws.
 - Conducting financial examinations of domestic and foreign insurers to assure compliance with Wisconsin regulations and rules.
 - Monitoring the financial status of licensed companies and applicant companies to provide early warning of financial difficulty.
 - Issuing licenses to companies, agents, brokers, surplus lines brokers, managing general agents, reinsurance brokers and managers, and organizations including employee benefit plan administrators.
 - Examining and analyzing rates filed by insurance companies to determine if they are excessive, inadequate, or unfairly discriminatory.
 - Investigating and processing consumer complaints against agents and insurance companies and attempting to bring the matter to a fair and reasonable conclusion.
 - Researching special insurance problems through data collection and analysis and publishing conclusions and recommendations in special reports.
 - Developing legislation and promulgating administrative rules that ensure a strong insurance market through proactive policy and skillful enforcement.
 - Investigating and pursuing administrative actions against agents and insurers who violate Wisconsin insurance laws and regulations. Penalties include suspension or revocation of licenses and fines.
 - Conducting a comprehensive program of consumer education and public information to educate consumers about insurance through public speaking and distribution of information booklets and comparison guides.
 - Operating a state life insurance fund, a property fund for the property owned by local units of government, and a patients compensation fund insuring health care providers for medical malpractice.

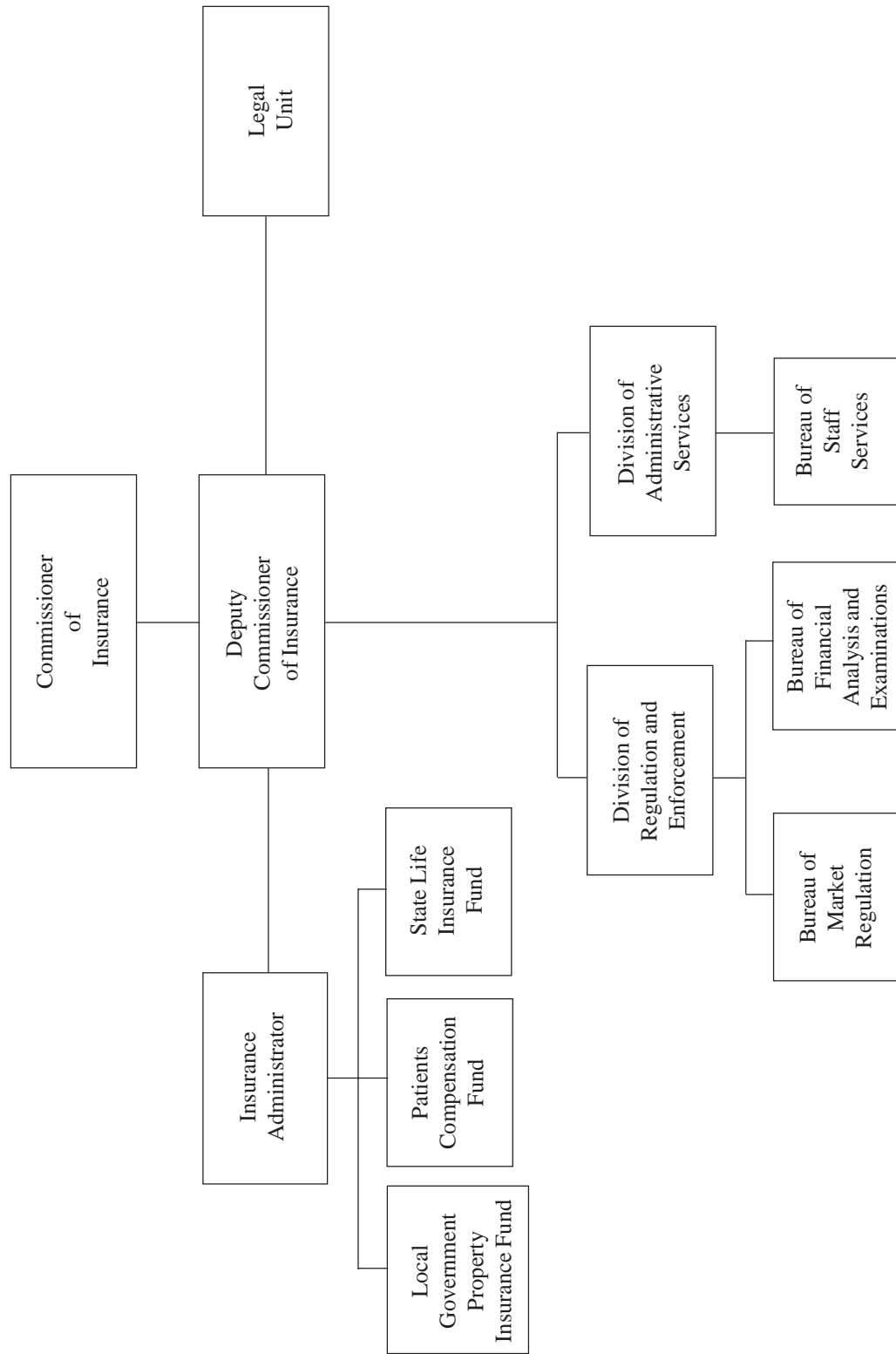

**Organization and Staffing of the
Office of the Commissioner of Insurance**



Organizational Structure

The office is divided into the Insurance Administrator area, the Legal Unit and two divisions, the Division of Regulation and Enforcement and the Division of Administrative Services.

Insurance Administrator

This unit provides advice on executive matters affecting the office's goals and initiatives, directs the office's legislative initiatives, communications activities, and provides advice on technical insurance-related issues.

The OCI managed care specialist, who serves as an ombudsman for consumers who have questions or problems with their managed care plans, is assigned to this unit. The managed care specialist investigates complex managed care complaints received by OCI and educates consumers on their rights under managed care plans. Implementing and administering the state's independent review program is the responsibility of the managed care specialist.

This unit also has administrative responsibilities for three segregated funds: the Local Government Property Insurance Fund, the Patients Compensation Fund, and the State Life Insurance Fund.

The Local Government Property Insurance Fund offers property insurance protection to qualified local government units.

The Patients Compensation Fund provides medical malpractice protection to health care providers for claims in excess of \$400,000 per claim or \$1,000,000 annual aggregate for each policy year.

The State Life Insurance Fund offers life insurance to Wisconsin residents in amounts not exceeding \$10,000 per person.

Legal Unit

The Legal Unit represents the office in administrative proceedings, provides legal advice to staff, represents or supervises representation of the office in litigation and insurance company receiverships, provides legal services for the Patients Compensation Fund, Wisconsin Health Care Liability Insurance Plan, Local Government Property Insurance Fund and State Life Insurance Fund, and develops legislative proposals and administrative rules.

Division of Regulation and Enforcement

Bureau of Financial Analysis and Examinations. This bureau monitors the financial solvency of insurers licensed to do business in Wisconsin. It conducts field audits of domestic insurer operations, administers insurer rehabilitations and liquidations, audits and collects insurer taxes and fees, and administers the fire department dues program.

Bureau of Market Regulation. This bureau reviews the rates, forms, and contracts filed with the agency by insurers; determines compliance with applicable laws and rules; initiates appropriate administrative actions; examines insurer rating procedures, advertising files, and policyholder reserves; staffs several risk-sharing plans; provides assistance to consumers in resolving problems with insurers and agents; disseminates information to the public; investigates agent activities; conducts field reviews of insurer marketing practices; and administers the insurance intermediaries testing and licensing program.

Division of Administrative Services

Bureau of Staff Services. This bureau is responsible for all general administrative functions of the agency including information technology, budget, accounting, contracting, purchasing, human resources, facilities management, and support services.

Executive Actions





Regulatory Developments and Trends

Wisconsin has maintained a healthy, competitive insurance market for a long time. Our auto insurance premiums continue to be among the lowest in the country, as do our homeowner's premiums. We continue to make sure our citizens are offered a wide variety of affordable insurance products. This is the direct result of Wisconsin's reasonable regulatory climate, the competitive insurance environment in this state and informed insurance consumers. During 2001 OCI continued to be involved in a number of initiatives to ensure that effective insurance regulation is maintained; Wisconsin policyholders continue to be adequately protected and that a stable business base for Wisconsin domestic insurers is provided.

Regulatory Protections

Governor McCallum's original budget included provisions to strengthen and modernize OCI's regulatory efforts. The Governor recognizes our regulatory approach needs to change with the times. With the growing presence of insurers on the Internet, the Governor supported creation of an examiner position that would specialize in Internet surveillance and enforcement.

Changes to our managed care regulation have also been adopted; the most significant is to rename managed care plans as defined network plans. In addition, these provisions modify how some of the regulations that apply to preferred provider organizations (PPOs) while at the same time ensuring that all Wisconsin residents who receive coverage from a defined network will have thoughtful and effective regulation of this product.

Consumer Initiatives

Ensuring that all consumers are knowledgeable about their rights is a critical part of OCI's mission. Consumer complaints are a vital source of information about current insurance issues affecting consumers or the insurance industry. This information is used not only to handle individual complaints but also to guide the agency in identifying issues requiring further analysis, public education, or legislation. In 2001 OCI was involved in numerous initiatives to help individuals and families make informed decisions about their insurance needs. Following is a synopsis of major innovations and accomplishments:

- Publishing *The Governor's Task Force on Small Employer Health Insurance Final Report*. The Task Force was created to address pressures on Wisconsin's small business insurance market and

to look at ways to encourage a healthy, competitive private market for small employers.

- Developing a variety of consumer information articles on products being marketed to the elderly. The emphasis of these articles has been to alert senior consumers to possible insurance and investment scams designed to deplete most or all of senior citizen's savings and retirement funds by selling fraudulent products.
- Surveying insurers that write auto and homeowner's insurance and have the largest market shares in Wisconsin and publishing a summary of how insurers use credit information in the underwriting and rating process. The information provided in the survey was used as part of a presentation at a Milwaukee urban outreach meeting with community and neighborhood leaders, consumers, agents and insurers.
- Improving consumer awareness of insurance issues related to property and casualty insurance policies. Through a series of press releases OCI has encouraged Wisconsin consumers to regularly review their insurance needs and update coverage as appropriate. No one wants a situation where it is discovered after the fact that they have inadequate insurance coverage.

Advances in Technology

Wisconsin consumers and the insurance industry are increasingly demanding continuous availability to information. OCI continues to aggressively infuse technology in order to improve user applications and to more efficiently serve our internal and external customers. The commitment to the use of technology is a key strategy in the agency's business plan. Technological accomplishments in 2001 include:

- Enhancing and improving information on our agency's Web site. The home page now immediately connects the user with four subcategories; information for consumers, agents, companies and a department overview; a new address; "quick links" to the insurance complaint form; agency statutes and regulations; licensure information and consumer publications; and a site index to allow users to find information without going through pages of information.

- Implementing COSMOS, a third-party vendor developed software system, to perform a variety of insurance regulatory functions, including agent and company licensing, invoicing and rates and forms filings.
- Implementing a new complaint tracking system to track all consumer complaints against agents and insurance companies.
- Improving and automating the financial and market conduct examination processes through the use of tools such as TeamMate 2000, an electronic workpaper software and ACL, an audit software tool.
- Developing an imaging capability to electronically store, retrieve and view large amounts of OCI documents including rates and forms filings, producer applications and company incorporation papers.

State Regulation Modernization

The National Association of Insurance Commissioners (NAIC) is continuing its ongoing and ambitious agenda to enhance state regulation of insurance by promoting uniformity and greater efficiency for agent and company licensing, while speeding up the process for bringing new products to market. OCI was involved with several of the (NAIC) efforts to advance the efficiency of electronic transmission of information. Major accomplishments include:

- Receiving recognition by the NAIC for successfully implementing all 12 technology-based initiatives in the Uniform Regulation Through Technology (URTT) program. The URTT initiatives boost state efficiency by streamlining the communication between insurers and regulators.
- Becoming one of the first states to accept rate and form filings in all lines of insurance electronically through the System for Electronic Rate and Form Filing (SERFF). SERFF assists states and insurers in reducing the time and cost involved in making regulatory filings.
- Participating as a pilot state for the National Producer Database project. The database will speed up and simplify the licensing process and provide benefits to both regulators and industry.

Emerging Trends

The goal for modernizing the state regulatory system is to make it easier for companies to get products to market and to provide the insurance buying public with the best available products at reasonable and actuarially sound prices. Wisconsin's regulatory model of insurance fosters a competitive market that operates to the advantage of both insurers and policyholders. Competition holds down premiums, but encourages insurer improvement in the delivery of their services. It also provides regulators with the flexibility needed to address problems that may arise. We will continue to work cooperatively with all our partners—the governor, our state legislators, federal officials, consumers, insurance companies, agents and other interested parties to facilitate and enhance the new and evolving insurance marketplace.

Legislation

During 2001, Governor McCallum signed legislation that affects the business of insurance in Wisconsin. Legislative materials may be obtained from the Revisor of Statutes, 1 E. Main St. (Lower Level), Madison WI 53702, or by calling (608) 266-2011.

The list of Wisconsin laws follows:

2001 Wisconsin Act 16 – Biennial Budget

Section: s. 100.52, Wis. Stat.

Defines a telephone solicitor and creates a “do-not call” list for telephone solicitations. The Department of Agriculture, Trade, and Consumer Protection (DATCP) has primary enforcement responsibility for this law.

Effective September 1, 2001

Section: s. 601.73, Wis. Stat.

Entitles plaintiffs or complainants to a judgement by default after 20 days after mailing date of service process by OCI if the proceeding is to foreclose or otherwise enforce a lien or security.

Effective September 1, 2001

Section: Ch. 609, Wis. Stat.

Replaces the term “managed care plan” with “defined network plan” throughout the statutes. Amends the statutory requirements for preferred provider plans (PPPs), so long as the PPP does not require or impose financial incentives related to referrals.

Effective September 1, 2001

Section: ss. 628.46(2m) and 632.875(2) (intro), Wis. Stat.

Provides that a claim for payment for chiropractic services must be paid within 30 days after the insurer receives clinical documentation from the chiropractor, unless, on the basis of an independent evaluation, an insurer restricts or terminates a patient’s coverage for treatment.

Effective September 1, 2001

Section: ss. 635.02(2) and 635.05(2)(a), Wis. Stat.

Removes occupation from the definition of case characteristic and includes occupation as a health related rating factor subject to rate bands.

Effective for policies issued or renewed after October 2, 2002

Section: s. 635.12, Wis. Stat.

Requires small employer insurers to annually publish their new business premium rates according to rules established by OCI.

Effective October 1, 2002

2001 Wisconsin Act 37 – Changes to the Worker’s Compensation Law

Section: Ch. 102, Wis. Stat.

Makes various changes to worker’s compensation laws in the state.

Effective January 5, 2001

Administrative Rules

In 2001, OCI promulgated the following changes in the Wisconsin Administrative Code:

Ins 3.39—Relating to Medicare Supplement and Replacement Plans

These changes bring the Wisconsin regulations in compliance with changes in federal law under H.R. 5661, the Balanced Budget Refinement Act and the Ticket To Work And Work Incentives Improvement Act of 1999 that amend section 1882 of the Social Security Act which governs Medicare Supplement Insurance and Medicare, Medicaid and SCHIP Benefits Improvement and Protection Act of 2000 (BIPA). Further, these changes are also necessary to conform with the National Association of Insurance Commissioners (NAIC) Medicare Supplement Insurance Minimum Standards Model Act.

The changes specifically address the guaranteed issue provisions, the suspension of benefits and premiums and the Medicare + Choice areas of federal preemption. The changes also include the following: reference to a new federal program, Program of All-Inclusive Care for the Elderly (PACE), created under the Social Security Act; provisions for notice and election rights of those whose Medicare+Choice plan is terminated; modification to the notice that is provided to applicants describing Part B benefits within Medicare Supplement policies; and repeal of the sections regulating the sale of Medicare+Choice plans due to federal preemption.

Effective November 1, 2001

Ins 3.455 and 3.46 and Appendices—Relating to Long-Term Care

These proposed amendments and additions to ss. Ins 3.455 and 3.46, Wis. Adm. Code, rely heavily upon a recent redraft of the NAIC long-term care model regulation. That regulation and these proposed amendments and additions attempt to enhance consumer protection in long-term care insurance policies. The development and marketing of long-term care insurance policies will broaden as the population ages. These changes will provide the proper regulatory incentives to require insurers to properly price these insurance products so that premiums can be kept stable. The rule requires enhanced consumer disclosure and notification designed to ensure that prospective applicants have sufficient information to make informed decisions about the coverage and the insurance company.

This rule also seeks to help promote uniformity in the national marketplace by essentially following the language and intent of a model act designed for promulgation in all the states. With these standards in place insurers can more easily design new products and modify existing products with some assurance that the products will be accepted in all the states. The model act was also designed to help address some of the tax issues that flow from long-term care insurance products.

Effective January 1, 2002

Ins 13 and 50—Relating to Changing Financial and Other Requirements for Town Mutuals

The changes to ch. Ins 13, Wis. Adm. Code, reflect both recent statutory changes to the operation of town mutuals and today's economic realities. This rule increases the number of counties in which a town mutual may do business, extends the fidelity bond requirement table, increases surplus requirements and eliminates obsolete sections on unearned premium reserves. The change to ch. Ins 50, Wis. Adm. Code, conforms to the ch. Ins 13, Wis. Adm. Code, changes and broadens the exemption from filing annual audited financials for some town mutuals.

Effective January 1, 2002

Ins 17.01 (3), 17.28 (6) and 17.28 (6a)—Relating to Annual Patients Compensation Fund and Mediation Fund Fees for Fiscal Year Beginning July 1, 2001

The Commissioner of Insurance, with the approval of the Board of Governors (Board) of the Patients Compensation Fund (Fund), is required to establish by administrative rule the annual fees which participating health care providers must pay to the Fund. This rule establishes those fees for the fiscal year beginning July 1, 2001. These fees represent a 20% decrease compared with fees paid for the 2000-01 fiscal year. The Board approved these fees at its meeting on February 28, 2001, based on the recommendation of the Board's actuarial and underwriting committee.

The Board is also required to promulgate by rule the annual fees for the operation of the patients compensation mediation system, based on the recommendation of the director of state courts. This rule implements the director's funding level recommendation by establishing mediation panel fees for the next fiscal year at \$38.00 for physicians and \$2.00 per occupied bed for hospitals, representing no increase from 2000-01 fiscal year mediation panel fees.

Effective July 1, 2001

Ins 18—Relating to Grievance Procedures and Independent Review Organizations

The creation of ch. Ins 18, Wis. Adm. Code, reflects the provisions of 1999 Wisconsin Act 155 that introduced the use of Independent Review Organizations in the state as a means for policyholders and claimants of health benefit plans to challenge certain decisions made by such plans. In addition, 1999 Wisconsin Act 155 renumbered portions of ch. 609, Wis. Stat., to relate in sequence the utilization of independent review with established grievance procedures.

Effective December 1, 2001

Ins 23—Relating to Standards for Insurance Marketed to Fund Prearranged Funeral Plans

The purpose of this rule is to repeal ss. Ins 23.35 and 23.40, Wis. Adm. Code, and further amend ch. Ins 23, Wis. Adm. Code, as necessary to conform to recent legislation contained in 1999 Wisconsin Act 91 (s. 632.415, Wis. Stat.). Among other things, 1999 Wisconsin Act 91, effective July 1, 2000, removed from the Commissioner the authority to set minimum standards for benefits and compensation arrangements for funeral policies. The current rule ch. Ins 23, Wis. Adm. Code, contains standards for these and other aspects of funeral policies. The proposed rule change will repeal those standards that conflict with the legislation and make other changes as required to bring the rule into compliance with the legislative mandate. Pursuant to s. 227.16 (2) (b), Wis. Stat., no public hearing is required.

Effective February 1, 2001

Ins 25—Relating to Privacy of Personal Information (Note: Due to a number conflict with a pending rule, this was changed from Ins 19.)

This rule is based on the NAIC model Privacy of Consumer Financial and Health Information Regulation. That model was prepared by the NAIC to meet the requirements of Title V of the federal Gramm-Leach-Bliley Act (GLBA). The objective of the NAIC in preparing that model was to achieve uniformity with the federal privacy rules for financial information.

The NAIC model addresses nonpublic personal health information more comprehensively, and with greater protection, than provided under the GLBA federal privacy rules. The NAIC concluded that the insurance industry has unique access to nonpublic personal health information such that greater protection than provided under the federal privacy rules was warranted. This rule incorporates the NAIC provisions concerning nonpublic

personal health information, but applies those provisions only to the extent that state law does not already provide protection for health information. State law currently includes provisions that govern patient health care records obtained from providers and provisions that govern information insurers obtain directly from individuals in connection with personal lines insurance (for example life, home, automobile and health insurance). Accordingly, the NAIC (and this rule's) provisions governing nonpublic personal health information primarily apply to information an insurer obtains from an individual in connection with administration of commercial property and casualty insurance.

Effective July 1, 2001

Ins 50.06 (2) (f)—Relating to Notes to Financial Statements

This rule change relates to the required footnotes in the CPA audit report on the statutory financial statements of insurance companies.

Under the existing s. Ins 50.06 (2) (f), Wis. Adm. Code, the footnotes include those required by the NAIC annual statement instructions and by generally accepted accounting principles. The footnotes shall also include: (1) a reconciliation of the differences, if any, between the audited statutory financial statements and the annual statement filed by the company under s. Ins 50.20, Wis. Adm. Code, and (2) a summary of the ownership and relationships between the insurance company and all affiliates.

Effective November 1, 2001

In 2001, OCI had the following emergency rules in effect:

Ins 6.50, 6.57, 6.58, 6.59, 6.595, 6.61, 6.63, 26 and 28—Relating to Revising Wisconsin Agent Licensing Rules to be Reciprocal and More Uniform Under Gramm Leach Bliley Act (GLBA) and the NAIC Producer Model

Under the recently enacted federal GLBA, Wisconsin and other states must become reciprocal or uniform in certain licensing practices. These changes would accomplish reciprocity.

The changes would also attempt to make insurance producer licensing more uniform and simplify multi-state licensing. If Wisconsin and at least 27 other states do not enact reciprocal or uniform rules regarding licensing, a federal licensing body similar to the National Association of Securities Dealers would be created to take over insurance agent licensing functions from the states. The

NAIC model Producer Act was developed by state insurance regulatory bodies to accomplish this and this rule adopts many provisions of the NAIC model.

Effective November 9, 2001

Ins 17.01 (3), 17.28 (6a) and 17.28 (6)—Relating to Annual Patients Compensation Fund and Mediation Fund Fees for the Fiscal Year Beginning July 1, 2001

The Commissioner of Insurance, with the approval of the Board of Governors (Board) of the Patients Compensation Fund (Fund), is required to establish by administrative rule the annual fees which participating health care providers must pay to the Fund. This rule establishes those fees for the fiscal year beginning July 1, 2001. These fees represent a 20% decrease compared with fees paid for the 2000-01 fiscal year. The Board approved these fees at its meeting on February 28, 2001, based on the recommendation of the Board's actuarial and underwriting committee.

The Board is also required to promulgate by rule the annual fees for the operation of the patients compensation mediation system, based on the recommendation of the director of state courts. This rule implements the director's funding level recommendation by establishing mediation panel fees for the next fiscal year at \$38.00 for physicians and \$2.00 per occupied bed for hospitals, representing no increase from 2000-01 fiscal year mediation panel fees.

Effective July 1, 2001

Advisory Boards and Councils

Wisconsin law, s. 15.04, Wis. Stat., provides that heads of independent agencies may create and appoint such councils and committees as the operation of the agency requires. The insurance law, s. 601.20, Wis. Stat., authorizes the Commissioner to create advisory councils and committees to assist in dealing with regulatory problems. The Commissioner is to provide by rule for the creation, governance, duties, and termination of any council or committee that is established. The expert advice provided the Commissioner through these councils results in more efficient regulation of the insurance industry to the benefit of insurance consumers and insurers.

The Commissioner and staff members also serve on various councils and boards and thus aid Wisconsin residents by providing advice and suggestions on matters related to insurance regulation.

A description of the various councils and boards with which OCI is involved follows:

Group Insurance Board (Board)

Section 15.165 (2), Wis. Stat., created a Group Insurance Board in the Department of Employee Trust Funds. The Commissioner or designee is a member of the Board. The Group Insurance Board is authorized to enter into contracts with insurers to provide group insurance plans or to provide the benefits on a self-insured basis. It also provides general administrative policy for the group insurance programs for health care, income disability benefits, and life insurance authorized for state and other public employees under ch. 40, Wis. Stat. The specific powers of the Board are enumerated under s. 40.03 (6), Wis. Stat.

Insurance Security Fund Board (Board)

This Board administers the Insurance Security Fund established by ch. 646, Wis. Stat., to provide a mechanism for protecting insureds in the event of liquidation of insurers and to assess the cost of such protection among insurers. The Commissioner, along with the Attorney General, and the State Treasurer, are members of this Board and serve with ten representatives of insurers appointed by the Commissioner upon consideration of the recommendation of insurance organizations.

Patients Compensation Fund Board (Board)

The Board was created by s. 619.04 (3), Wis. Stat. It is a 13-member Board that consists of 3 insurance industry representatives, a member named by the Wisconsin Academy of Trial Lawyers, a member named by the State Bar Association, 2 members named by the State Medical Society of Wisconsin, a member named by the Wisconsin Hospital Association, 4 public members appointed by the Governor, and the Commissioner who serves as the chair. Wisconsin Retirement Board

The Wisconsin Retirement Board is created in the Department of Employee Trust Funds by s. 15.165 (3) (b), Wis. Stat. It is a nine-member Board. Six members represent employers or employees who participate in the Wisconsin retirement system, one is a participating state employee, one is a public member, and one is the Commissioner or an experienced actuary in OCI. The Board studies and recommends alternative administrative policies, authorizes and terminates disability annuity payments, and considers administrative rules that relate to participants in the retirement system other than teachers.

Council on Fire Service Training Programs

This body, authorized by s. 15.947, Wis. Stat., functions under the State Board of Vocational, Technical and Adult Education, and furnishes advice and guidance to the Board in the establishment and maintenance of training programs in fire prevention and protection. The council is comprised of representatives from the Division of Emergency Government (Bureau of Civil Defense and Disaster Control), the Department of Workforce Development, and OCI, together with six members of fire departments appointed by the Governor for staggered six-year terms.

Joint Survey Committee on Retirement Systems

This committee performs duties mandated under s. 13.50, Wis. Stat. The committee is comprised of two majority party senators, one minority party senator, two majority party representatives to the assembly, one minority party representative to the assembly, an assistant attorney general, a member of the public selected by the Governor, the Commissioner or a designated experienced actuary in OCI, and the Secretary of the Department of Employee Trust Funds.

This committee evaluates all legislative proposals that would create or modify any system of retirement for public officers or employees. No such bill may be acted upon by the legislature until it has been referred to this committee for preparation of a written report. The report must indicate the probable cost involved, the effect of the proposal upon the actuarial soundness of existing retirement systems, and the desirability of the proposal as a matter of public policy.

Retirement Research Committee

This committee performs duties mandated under s. 13.51, Wis. Stat. Its membership represents employee and employer groups having vested interests in various state retirement programs. The committee has investigatory powers over all state retirement systems for public employees. In addition, it may require any public pension or retirement system to furnish it with periodic financial reports and records. The committee conducts a continuous review of retirement benefits afforded to public employees under the existing state system. It maintains a current reference library of all public employee pension and retirement plans throughout the United States and makes its findings and recommendations available to the Governor and the legislature.

Life and Disability Advisory Council

This council, created by s. Ins 6.79, Wis. Adm. Code, advises the Commissioner on regulatory matters in the areas of life and disability insurance. The council has four insurance company members, two agent members, and three public members. The members during 2001 were:

Bulletins to Insurers

February 20, 2001: To all Wisconsin domiciled insurers licensed to issue disability insurance regarding 2001 statutory accounting treatment for health care receivables. This bulletin advises Wisconsin domiciled insurers on how to report the Health Care Receivables under the new Statements of Statutory Accounting Principles that took effect on January 1, 2002.

March 1, 2001: To all Wisconsin domiciled workers' compensation insurers regarding prescribed accounting practice and audit premiums receivable. This bulletin discusses the due date for audit premiums for worker's compensation policies.

June 19, 2001: To all insurers licensed to do business in Wisconsin regarding privacy of consumer financial and health information. Ch. Ins 25, Wis. Adm. Code, is based on the National Association of Insurance Commissioners (NAIC) Privacy of Consumer Financial and Health Information Model Regulation. The model was prepared by the NAIC to meet the requirements of Title V of the federal Gramm-Leach-Bliley Act (GLBA). Under ch. Ins 25, Wis. Adm. Code, a licensee is required to provide written notice of its privacy policies and practices. The rule describes the conditions under which the licensee may disclose nonpublic personal financial information. Ch. Ins 25, Wis. Adm. Code, establishes requirements for privacy notices. The rule also establishes restrictions on the sharing of health information.

July 10, 2001: To all insurers licensed to do business in Wisconsin regarding filing procedures for insurance applications developed to allow depository institutions to meet their disclosure obligations under Section 305 of The Gramm-Leach-Bliley Act. The federal banking agencies promulgated consumer protection regulations pursuant to Section 305 of the Gramm-Leach-Bliley Act (GLBA), governing the sale of insurance products by depository institutions. Among other things, the regulations require depository institutions that sell insurance products to make certain disclosures and receive consumer acknowledgements, which are intended to reduce consumer confusion in the sale of insurance products by depository institutions. To best ensure that these requirements are met, depository institutions may prefer to have these disclosures included on insurance application forms. In order to comply with the federal regulations in this fashion, depository institutions that sell insurance products will need to ask insurers to make the

necessary filings with appropriate State insurance regulators. These form filings would be subject to the filing and review requirements under section 631.20, Wis. Stats.

July 23, 2001: To all long term care insurance companies doing business in Wisconsin regarding amendments to Sections Ins. 3.455 and 3.46, Wis. Adm. Code. This bulletin is to inform insurers that on July 1, 2001, significant amendments were made to Wisconsin's long term care insurance administrative rules, ss. Ins. 3.455 and 3.46, Wis. Adm. Code. The changes to Wisconsin's long term care insurance regulations are materially consistent with the recent rating practice and consumer protection provisions of the NAIC Long Term Care Insurance Model Act and Regulation. The changes to the rule are not effective until January 1, 2002 for policies issued on or after that date.

August 15, 2001: To all licensed insurers regarding conversion to new agent licensing system and change in billing dates. This bulletin discusses the changes that will take place when the agent licensing computer system converts to COSMOS.

August 20, 2001: To all town mutual insurers licensed under ch. 612, Wis. Stat. certain domestic insurers licensed under Ch. 611, Wis. Stat., and certain reinsurers regarding amendments to Chapter Ins 13, and section Ins 50.02, Wis. Adm. Code. This Bulletin describes the changes to ch. Ins 13 and s. Ins 50.02, Wis. Adm. Code.

October 11, 2001: To all property and casualty insurance companies regarding property and casualty rate/rule filing procedures. The purpose of this bulletin is to update the outline of the requirements for the filing of rates and supplementary rate information (rules) required by s. 625.13 (1), Wis. Stat., and s. Ins 6.06, Wis. Adm. Code. It applies to all lines of property and casualty insurance except worker's compensation.

October 22, 2001: To all licensed insurers regarding company appointments and terminations. This is a follow up to the bulletin sent to all licensed insurers dated August 15, 2001. Due to the conversion to the COSMOS system, insurers are now required to provide each agent's social security number as well as the line(s) of authority requested for each individual appointment. The bulletin informs insurers how to locate the forms to appoint or terminate agents.

October 22, 2001: To all insurers authorized to do business in Wisconsin regarding newly enacted legislation—2001 Wisconsin Act 16 and implementation of Ins 18, Wis. Adm. Code—Independent Review of Health Plan Decisions. This bulletin contains a summary of the provisions of 2001 Wisconsin Act 16 (SB 55), the 2001-2003 Biennial Budget and important information regarding the implementation of Ins 18, Wis. Adm. Code, which directly affect OCI and the insurance industry. Copies of any legislation may be obtained from Legislative Documents, 1 East Main Street, Madison, WI 53703 and (608) 266-2400 or through the Legislature's Web site at www.legis.state.wi.us.

November 2, 2001: To all insurers authorized to do business in Wisconsin regarding changes in form filing procedures. Wisconsin has new requirements for submitting form filings, effective immediately. A summary of all valid Product Categories and Product Codes is attached to the bulletin.

November 19, 2001: To all insurers writing credit life and disability insurance, individual accident and health insurance, long term care insurance and/or Medicare supplement insurance regarding individual accident and health rate filing procedures, credit life and disability rate filing procedures, long term care insurance rate filing procedures, and Medicare supplement rate filing procedures. The purpose of this bulletin is to outline the requirements for the filing of rates and supplementary rate information (rules) required by s. 625.13 (1), Wis. Stat., and ss. Ins 3.13, 3.39, 3.455, Wis. Adm. Code. Information regarding rate filings for property and casualty can be found in the October 11, 2001 Property and Casualty Rate/Rule Filing Procedures Bulletin.

December 6, 2001: To all Medicare supplement insurers regarding guaranteed issue requirements under special enrollment periods for Medicare + Choice enrollees. The purpose of this Bulletin is to notify insurers that Medicare + Choice enrollees in the State of Wisconsin have a December Special Election Period with the same guaranteed issue protections as if their plan had terminated. Therefore, Medicare supplement and Medicare select insurers must issue coverage without any pre-existing condition exclusions to those Medicare + Choice enrollees who choose to leave the Medicare + Choice organization.

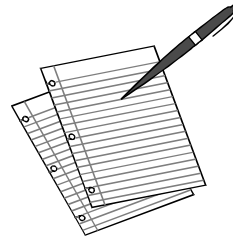

Local Government Property Insurance Fund (Fund)

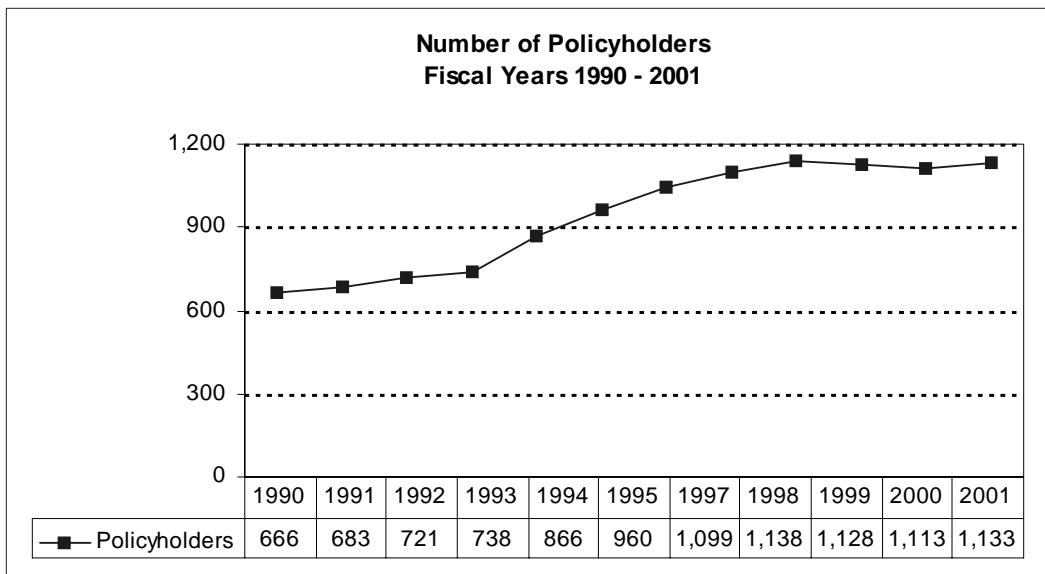
The purpose of the Fund is to make reasonably priced property insurance available for tax-supported local government property such as government buildings, schools, libraries, and motor vehicles. The Fund provides policy and claim service to the policyholders.

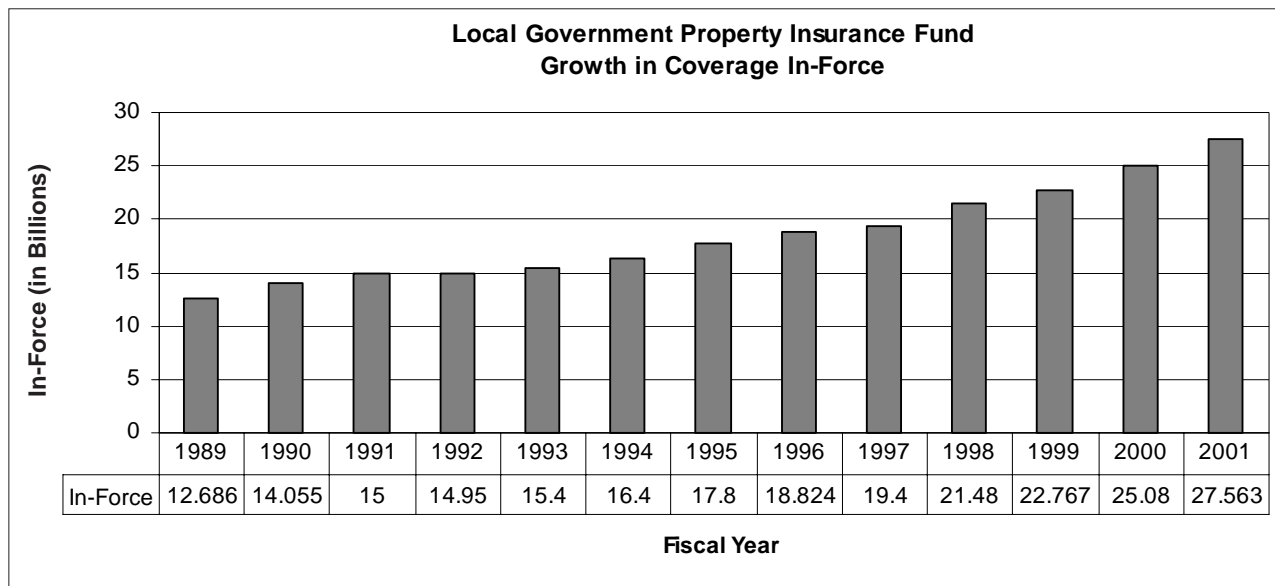
As of June 30, 2001, the Fund insured 1,133 policyholders: 71 counties, 296 schools, 151 cities, 281 towns, 221 villages, and 113 miscellaneous (libraries, etc.). The number of policyholders increased by 20 (1.8%) since the previous fiscal year-end. Two graphs are included that reflect growth in the Fund's policyholder base and growth in its insurance coverage in force. The total amount of insurance in force as of June 30, 2001, was \$27.6 billion, up from \$25.1 billion as of the previous fiscal year-end.

Two pie charts reflecting premium earned distribution by type of policyholder and the breakdown by type of policy purchased are also attached. The majority of the Fund's insureds are using the valuation project service that began in 1988. This unique method of valuing buildings, contents, property in the open, and contractor's equipment was developed to promote equity in premiums and the proper reporting of values. Participants not only have broader coverages, but enjoy the benefits of automatic computer-generated statements of values.

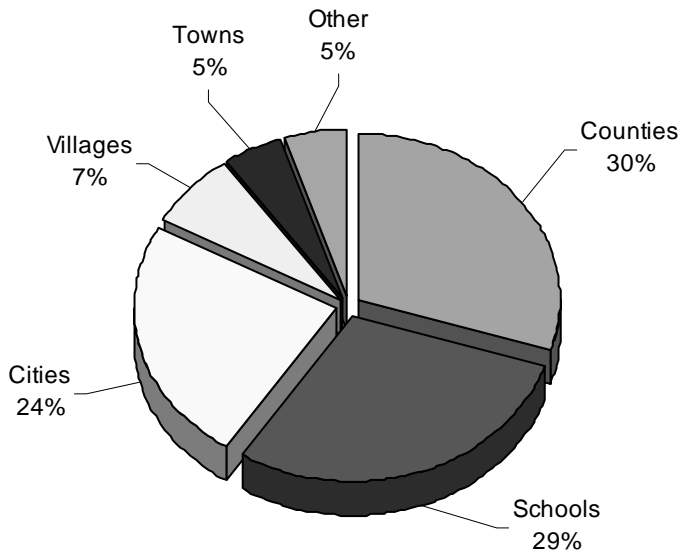
During 1998 the Fund modified its valuation policy form coverage with respect to replacement coverage for fine arts, collectible items, and museum collections. These changes were necessary to permit the Fund to better assess its exposure relative to fine arts, collectible items, and museum collections which can have substantial replacement costs. Effective January 1, 1999, the most the Fund will pay for any one item is \$50,000. If, however, the insured desires higher amounts of coverage on a per item basis, it must either schedule the individual property and provide an estimated replacement value, or purchase an endorsement that offers coverage subject to per item, per exhibit, and per occurrence limitations.

Rates over the past five years have remained stable, however, due to an anticipated net loss and changes in the Fund's reinsurance program's retention levels, the Fund implemented a 24% increase in building and content rates effective July 1, 2001. The Fund's surplus actually decreased approximately \$2.7 million over the June 30, 2000, level, while its total insurance in force increased \$2.5 billion over the same time period. The Fund's insurance in force represents property that is insured against loss. The more property insured, the greater the potential for a loss. Claims costs coupled with higher self-insured Fund reinsurance retention levels and higher reinsurance premium will continue to be a factor in the rate-setting analysis. Fund management will continue to monitor insurance in force and claims trends when evaluating the Fund's rating structure. As of year-end 2001, the Fund was in the process of engaging an independent actuarial consulting firm to assist it with rating issues.

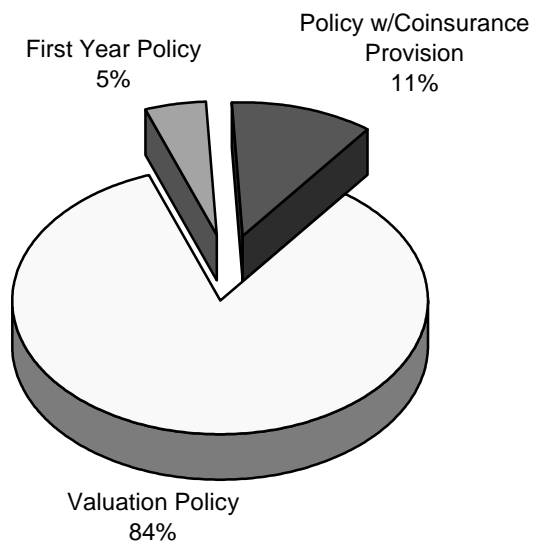




**Direct Premium Earned by Entity Type

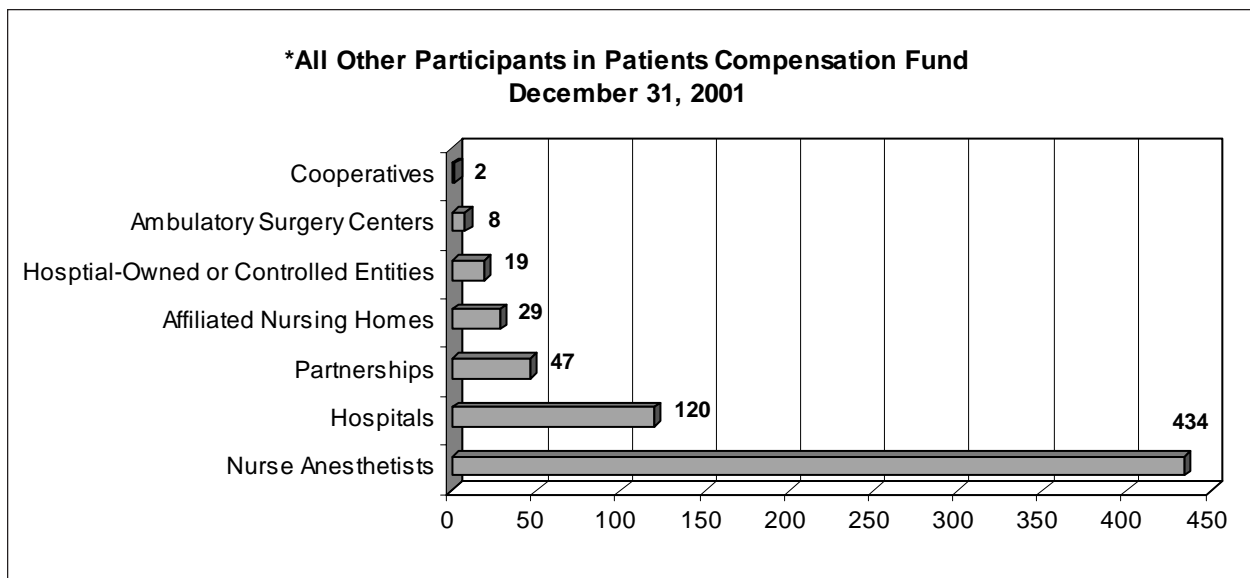
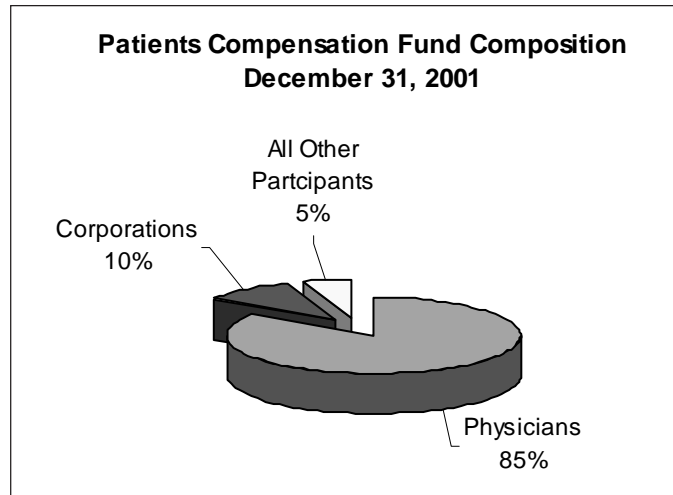
Patients Compensation Fund (Fund)

The Fund was created in 1975 to provide excess medical malpractice insurance for Wisconsin health care providers. The Fund is governed by a 13-member Board of Governors (Board) that consists of 3 insurance industry representatives, a member named by the Wisconsin Academy of Trial Lawyers, a member named by the State Bar Association, 2 members named by the State Medical Society of Wisconsin, a member named by the Wisconsin Hospital Association, 4 public members appointed by the Governor, and the Commissioner of Insurance who serves as the chair. The Fund's administrative staff is provided by OCI.

The Board is assisted by an Underwriting and Actuarial Committee, a Legal Committee, a Claims Committee, an Investment/Finance and Audit Committee, a Risk Management Steering Committee, and a Peer Review Council. The Board and its committees meet quarterly.

The Fund operates on a fiscal year basis—July 1 through June 30. Administrative costs, operating costs, and claim payments are funded through assessments on participating health care providers.





As of December 31, 2001, the vast majority of Fund participants were physicians at 85% with corporations comprising another 10% and the remaining 5% comprised of various other participant types, as illustrated in the charts above. At year-end 2001, Fund participants totaled 12,344 comprised of 10,418 physicians, 1,267 corporations, 434 nurse anesthetists, 120 hospitals with 29 affiliated nursing homes, 47 partnerships, 19 hospital-owned or controlled entities, 8 ambulatory surgery centers, and 2 cooperatives.

From July 1, 1975, through December 31, 2001, 4,615 claims had been filed in which the Fund was named. During this period, the Fund's total number of paid claims increased to 585, totaling \$507,692,824. Of the total number of claims in which the Fund has been named, 3,664 claims have been closed with no indemnity

payment. Of the remaining reported claims as of December 31, 2001, 32 cases carried aggregate case reserves of \$33,262,860.

Changes in the Fund's statutory investment authority have had a positive impact on the Fund. Legislation enacted in April 1990, which permitted the Fund to invest in long-term financial instruments, has resulted in higher investment earnings. The Fund's actuaries have estimated that during the period October 1, 1990, to September 30, 2001, investment earnings on the long-term portfolio were \$93.5 million greater than what would have been earned had these assets remained in the short-term account.

During 1999, the Investment Committee, with the assistance of an outside investment consultant, developed new investment guidelines. The new investment

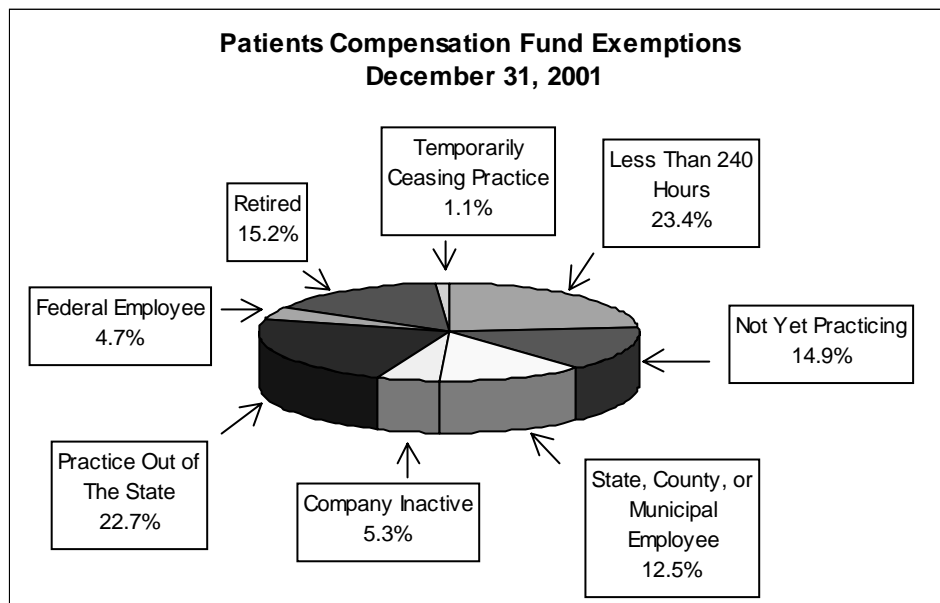
guidelines provide for investment in equities to maximize investment return. These new investment guidelines were implemented in 2000 in coordination with the State of Wisconsin Investment Board.

Major Activities for 2001:

- Fund administration, in conjunction with legal counsel, closely monitored claims filed which challenge the constitutionality of the noneconomic and wrongful death caps. This is an ongoing issue and will be closely monitored.
- Fund administration closely monitored the use of outside counsel. Pursuant to a court decision in 2000, the Fund hires separate defense counsel on each claim. Fund staff monitors the claims and the use of these outside counsel to ensure that while the Fund receives the necessary representation, that legal fees are controlled.

- The Fund is in the process of implementing late filing fees which will be charged to primary carriers when certificates are not received timely in accordance with s. Ins 17.28 (5), Wis. Adm. Code.

- Extensive work continued during 2001 to verify and process up-to-date exemption status for providers that held a license to practice in Wisconsin but for which a current exemption or certificate was not on file with the Fund. Providers that remain in noncompliance are referred to their respective licensing boards for enforcement action by that board. As of December 31, 2001, 9,159 providers claimed an exemption from the Fund. The various basis for the exemptions are illustrated in the chart below:

State Life Insurance Fund (Fund)

The Fund is a segregated fund located within OCI. The Fund offers a maximum of \$10,000 of life insurance to state residents. Operating as a mutual insurance company, the Fund is supervised by the Commissioner.

Section 607.15, Wis. Stat., requires the Fund to distribute annually among the policyholders its net profits and to the extent practicably possible, maintain a ratio of surplus to assets between 7% and 10%. In 2001, a

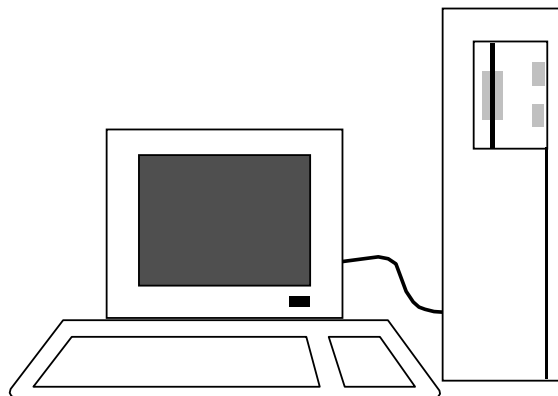
distribution of \$3.9 million was paid to policyholders in the form of dividends.

Wisconsin is the only state in the nation that offers a life insurance program to residents. All policies issued are participating and there is no marketing of the Fund. The lapse rate on Fund policies is a low .1%. As of December 31, 2001, there were 30,407 policies in force.

Division of Administrative Services





The administrator of the Division of Administrative Services supervises the division and is responsible for the supervision and monitoring of the agency budget, personnel activities, data processing, and general administrative services.

Information Services Section

On the application side of the Information Services Section, the following list was accomplished to improve user applications:

- Implemented the Complaints Tracking system to track all consumer complaints against agents and companies.
- Developed more than 15 Complaints system management reports for use in assigning and analyzing consumer insurance complaints against companies or agents.
- Implemented COSMOS—a third-party vendor developed software system—to perform a variety of insurance regulatory functions, including agent and company licensing, invoicing and rates and forms filings. Implementation required interchange of data with national registries by developing interfaces, downloads and uploads, and reports.
- Developed 25 reports for the COSMOS system to report revenue, analyze rates and forms filings, and generate billing notices.
- Developed an imaging capability to electronically store, retrieve and view large amounts of OCI documents including rates and forms filings, producer applications, and company incorporation papers.
- Completed the imaging of all State Life Insurance Fund files.
- Completed the imaging of forms files from previous years, and began imaging Agent Licensing back files.
- Set up hardware and user manuals for electronic public access to rates and forms information.
- Developed several business use cases used to program components of the new Premium Tax system used to calculate and administer the state's tax on insurance companies writing premiums in Wisconsin.
- Completed the Premium Tax Payment Processing system.
- Placed Premium Tax Payment Vouchers on OCI's Internet Web site.
- Developed a series of improvements for the Patients Compensation Fund system including: enhanced survey reports for corporations, enhanced certified letters and labels; enhanced certificate creator and

verifier program to handle errors appropriately and create files easier; new screens for users to enter ISO codes and provider types; a new logon program that utilizes the new security measurements; and automated the lockbox retrieval process.

- Updated the OCI Internet Web site to provide up-to-date information to insurance customers and the insurance industry.

On the technical side of the Information Services Section, the following list was accomplished to improve user access:

- Provided for replacement of laptop computers for financial examiners.
- Installed anti-virus patches to protect OCI users from several Internet viruses.
- Installed an additional server.
- Upgraded the Oracle database software to version 8.17.

On the management side of the Information Services Section, the following list was accomplished to improve program management:

- Adopted Issue Tracker as a means to track the status of resolving IT system errors and system enhancements.
- Provided on-site, low-cost training on PL/SQL for agency developers.
- Developed milestones for the move of the agency's IT operations to the GEF III Building in Madison.
- Designed the agency's Local Area Network room space at GEF III.
- Developed milestones for the shutdown and replacement of the agency's WANG minicomputer.
- Handled 798 calls to the IT help desk and resolved all but 55 problems within one day of notification.

Services Section

The Services Section provides basic and essential office services that not only facilitate the work of OCI staff, but assist the insurance industry and the general public as well. Service areas include records management, forms management, mail services, walk-in and telephone reception, Web site maintenance and management, service of process, and general office support.

Records Management

By providing records management for the entire agency, the records manager maintains agency-wide records and makes available public records.

The records manager is a liaison to agency business areas for issues involving records in all media, and the position is a liaison to outside agencies including the State Historical Society, the Department of Administration's Records Management Section, the Department of Electronic Government, and on cross-agency teams resolving records issues. The records manager attends meetings of the Wisconsin Information Resources Council, the State Web Administrator's Group, the E-Records Committee, and the Licensing and Permitting Portal team. The records manager is also part of agency committees and workgroups, including the Information Technology (IT) Strategic Planning Committee.

There are several records management practices currently in use at OCI. A central file of the agency Records Disposition Authorizations (RDAs) and general records schedules is maintained. In the process of analyzing business practices as they relate to records, a yearly inventory of records is conducted and an analysis of the need for new and revised RDAs is considered. Records storage information, including location, is tracked both on- and off-site by maintaining databases in Microsoft Access. This aids in the annual inventory of records on-site, and the rotation of some to the off-site storage facility.

Responses to open records requests for information are tracked closely by central files. The office expends great effort to respond quickly and efficiently to the many public requests we receive, and retaining statistics helps track our effectiveness. Records are provided to requesters via numerous formats: paper, microfilm, and electronic. Conversion of records to electronic format brings different challenges to fulfill open records requests. OCI has met that challenge head on and has installed a workstation from which rates and forms records can be viewed and queued for printing for those wishing copies. Additional

work will continue in providing access to requested records by electronic means.

The records manager also works with the database administrator and other IT staff, which allows input from a records viewpoint relating to the impact that the process of changing how our electronic data and records are stored has on records management issues. In this process, not only the content of the data is examined, but discussion also takes place regarding the migration of data between media and how the potential purchase of software/hardware might impact records.

Effective records management practices allow us to better serve the insurance industry and the general public, as well as our staff. Through operation of our Central Files Section, the records manager makes public records available. These records include:

- insurance company rates, approved policy forms, articles and bylaws, biographical sketches of officers and directors, financial examination reports, holding company registration, contracts, correspondence, and financial statements
- consumer complaint information (closed files only)

Publications Distribution

Also available through Staff Services are publications with helpful information for people shopping for insurance. Titles in greatest demand include:

- Guide to Long-Term Care
- Long-Term Care Insurance Policies Approved in Wisconsin
- Medicare+Choice Questions and Answers
- Medicare Supplement Insurance Approved Policies
- Wisconsin Guide to Health Insurance for People with Medicare

Mail Service

By offering centralized mail service to the agency, staff provides an essential office function. Mail room staff handles all incoming mail for the entire agency. The process involves receiving, opening, determining appropriate business area for response, date stamping, and sorting to mailboxes. The mailroom is also a central area where incoming faxes are received and distributed and package deliveries are accepted and announced. Mail room staff accumulates agency-wide outgoing mail in this area and prepares it for pick-up as well.

Reception Service

The first people met by visitors to the agency are our receptionists. These individuals greet all comers to our office and assist them in their business needs. As well as greeting and referring visitors, the receptionists take incoming telephone calls to the central switchboard, determine the needs of the callers, and transfer calls to appropriate staff. The reception staff also acts as a formal starting point for visitors to the agency. All visitors are now required to sign in. Visitors await staff with whom they are visiting to come and retrieve them from the reception area.

Web Service

Citizens increasingly interact with state agencies electronically. Agency staff also accesses information increasingly via electronic means. These interactions have grown substantially over the last few years, and particularly since Executive Order No. 408 was issued in 2000. This executive order directs all Executive Branch Agencies to incorporate digital age means of interaction with government by Wisconsin citizens and businesses. Staff Services provides the required staff and expertise in delivering content, as determined by program areas and the OCI Web Committee, to our internal and external web sites.

2001 Statistics

- Continued tracking of production statistics and performance measures for all service areas allowed us to gauge our progress in serving staff and the public.
- The switchboard referred a large number of calls incoming to the central switchboard. The average number of calls answered daily was 200.
- The service of process section has seen a decline in service of process requests. There has also been a decline in telephone inquiries for registered agent names and addresses. Registered agent contact information is more frequently found directly on OCI's Web site. There were 247 processes served by OCI in 2001. See the table below for Web site statistics regarding registered agent lookups.
- The OCI Internet site contains approximately 1,300 pages. Many OCI publications, forms, and other regularly requested material and information has been available on the site for several years. More is being published there regularly. Wisconsin citizens and businesses are finding the information at an increasing rate on the site. In the period July 22 through December 22, 2001, roughly 63,000 unique visitors visited the site.

Business Services Section

Business Services staff process all agency requests for printing, furniture, office supplies and contracts for services according to state procurement requirements with the intent of providing a most effective working environment for all agency staff. Business Services staff also provide accounts receivables cashing service, processing of vouchers for accounts payable, biennial and operating budget preparation, including monitoring, analysis and projections, and recording, analysis and reporting of all agency revenues and expenditures. Additionally, the Business Services Section, with the cooperation of building management, strives to achieve physical accommodations for maximum comfort, security, and safety, for staff and visitors alike.

Some of the accomplishments of the Business Services Section during the past year include:

- Prepared cost allocations for the company annual examination assessment.
- Prepared for the conversion of company billings to a common annual billing cycle.
- Revised the OCI Strategic Business Plan.
- Analyzed the 2001-03 biennial budget, and prepared operating budgets for each organization unit and each appropriation.
- Improved building security through the placement of signs, new check-in procedures, and the refinement of the building evacuation plan.
- Established a representative structure to allow agencywide participation in the design of downtown office space to which we will move by 2003.
- Created an Intranet resources page to answer employee questions, report progress, and provide design plans and related information regarding the impending relocation of the agency.
- Provided training on supplies and purchase cards.
- Processed 172 purchase orders, a reduction from 2000 due to expansion of the procurement card program.
- Oriented new supervisors to agency health and safety programs to improve early incident reporting, support for ergonomic equipment, and loss prevention.
- Contracted for services worth \$1.8 million.

Human Resources Section

The Human Resources Office is responsible for providing leadership and services to achieve a quality workforce to support the mission of the agency. The Human Resources Section provides support in the recruitment, hiring and retention of a skilled, committed and diverse workforce needed to provide high quality services to Wisconsin citizens. The function of the Human Resources Section encompasses personnel, payroll, benefits, employee education and training.

Some of the accomplishments of the Human Resources Section during the past year include:

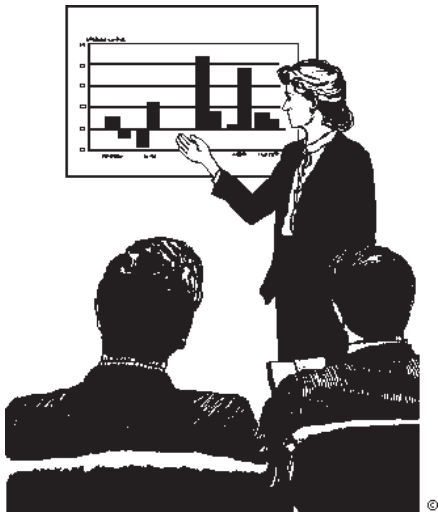
- Identified a solution to an on-going compensation problem, in cooperation with the Wisconsin Professional Employees Council and the Wisconsin Department of Employment Relations.
- Assisted in carrying out efforts to assure a safe work environment, in light of the September 11, 2001, terrorist attacks on the United States. State photo ID's were distributed, training on handling of suspicious mail was provided and information on "Terrorist Attacks and Talking to Children" was offered.
- Continued the agency's ongoing supported work efforts by renewing the employment of disabled individuals through the organization Community Work Services, Inc.
- Revised an exam process in order to take advantage of insurance regulatory technical knowledge gained within the agency and to allow career growth.
- Developed outreach letters directed to companies experiencing downsizing, informing them of employment opportunities with the State of Wisconsin.
- Provided a number of training and information sessions including:
 - √ New Supervisor Orientation
 - √ Family Medical Leave Act
 - √ Time Reporting System
 - √ Worker's Compensation
- Earned the Life Office Management Association's (LOMA) Excellence in Education Award which acknowledges the commitment made by companies to support and encourage professional development for their employees, which in turn prepares both the individuals and the companies to meet tomorrow's challenges.
- Expanded the agency's electronic examination administration to include not only the Life Office Management Association testing, but also testing for the American Institute of Chartered Property Casualty Underwriter.

Alternative Work Patterns

OCI is cognizant of the need to offer a flexible work environment in order to maximize the employment options available to existing and potential state employees and to meet the needs of our constituents. OCI encourages the utilization of alternative work patterns such as flex time, part-time, and shared-time schedules to increase productivity, extend services, reduce absenteeism, improve employee morale, allow for employee development, and maximize energy conservation through ridesharing and use of mass transit systems. Currently our staff includes two job-share arrangements and four

part-time permanent employees. The agency also reviews requests, on a case-by-case basis, from staff who wish to temporarily work from their home. The agency recognizes that alternative work pattern schedules may provide opportunities for individuals to productively utilize their skills, talents, and abilities. It recognizes that a traditional, full-time, work schedule may not meet the needs of individuals whom, due to age, health, or family circumstances, find such a schedule in conflict with responsibilities outside of work.

Division of Regulation and Enforcement





The Division of Regulation and Enforcement, through its Bureau of Financial Analysis and Examination and Bureau of Market Regulation, and in conjunction with the office's Legal Unit, is responsible for enforcing the state's insurance laws. In addition, the Division has primary responsibility in developing and maintaining the office's consumer publications and providing information and material to the office's Web site. In compliance with s. 601.01(5), Wis. Stat., the Division works with other state and federal regulatory agencies in carrying out the purposes of the Wisconsin insurance laws and the mission of the office.

Bureau of Financial Analysis and Examinations

The principal function of the Bureau of Financial Analysis and Examinations is to monitor the financial condition of all insurers licensed to market insurance in Wisconsin and determine whether an insurer's financial solidity is acceptable for continued operation in Wisconsin. Monitoring includes the examination of the accounts and records of companies and the analysis of financial statements submitted to OCI, the review of CPA audit reports, and updates to the company profile database.

The bureau maintains and reviews holding company filings required by ch. Ins 40, Wis. Adm. Code, reviews financial reports for surplus lines insurers, administers insurer applications for admission to Wisconsin, merger and acquisition plans, and holding company transactions.

Among the major accomplishments in 2001 were:

- Examination of 54 domestic insurers.
- Analysis of the financial statements of over 1,800 insurers.
- Licensed 21 nondomestic insurers, 16 gift annuities, 19 warranty plans, 3 domestic insurers, and 2 continuing care retirement communities.
- Reviewed and amended the Wisconsin certificate of authority for 10 nondomestic insurers that converted from mutual to stock form.
- Reviewed and approved changes of control of 13 domestic insurers, pursuant to holding company regulations.
- Approved 3 changes of domicile into Wisconsin and 1 change of domicile out of Wisconsin.
- Completion of the proposed conversion of Blue Cross & Blue Shield United of Wisconsin from a nonprofit service insurance corporation to a stock insurance corporation.
- Reviewed and enhanced procedures for financial analysis and monitoring of licensed insurers.
- Continued use of the revised NAIC Examiner Handbook and the continued use of risk assessment and materiality considerations in setting examination scopes.

- Completion of the proposed conversion of Employers Insurance of Wausau from a mutual to a stock insurance corporation under a mutual holding company plan.
- Continued use of TeamMate 2000, electronic workpaper software, to facilitate the financial examination process.
- Continued use of ACL, an audit software tool, in the financial examination process.
- Working on pilot project for companies to file Wisconsin-specific forms electronically over the Internet.
- Continued development of automated applications used in financial analysis and examinations.
- Maintained insurer financial and demographic data on the OCI Internet Web site.
- Maintained qualification for accreditation pursuant to the Financial Regulation Standards by the NAIC.
- Continued use of actuarial consulting firms on examination of major companies.
- Reviewed and enhanced examination procedures to ensure quality control.
- Continued use of Access software to download financial data from the NAIC annually and quarterly.
- Continued participation in OCI Information Technology Planning and Standards Committee charged with the development of comprehensive plans and standards for bureau and department-wide LANs.
- Continued implementation of, and staff training on, the NAIC I SITE Program. The PC-based technology improves and expedites access by examiners to the NAIC database, through applications which produce reports for financial analysis and examinations.
- Continued reengineering of OCI financial database and applications (with IT bureau).
- Participation in NAIC task forces and working groups, including: Accounting Practices and Procedures Task Force, Examination Oversight Task Force, Risk-Based Capital Task Force,

Analyst Team System Oversight, Audit Software, Emerging Accounting Issues, Financial Analysis Handbook (Chair), Financial Analysis Working Group, Financial Analysis Research and Development (Chair), Financial Examiners Handbook, Health Entities, Health Risk-Based Capital, Insurance Group Review, Insurance Holding Company, Life Risk-Based Capital,

Property and Casualty Risk-Based Capital, Property and Casualty Reinsurance, Statutory Accounting Principles, Risk Assessment, Risk Assessment Confidentiality.

- Annual and quarterly statement forms, tax forms, application packets, examination reports, demographic data, and financial information of insurers available on the OCI Internet Web page.

Companies in Liquidation

American Star Insurance Company, In Liquidation

American Star Insurance Company was placed into liquidation on November 16, 1992. Matthew C. Mandt is appointed as special deputy liquidator.

American Star is headquartered in Lafayette, California, and had business in force mainly in Arizona, California, Idaho, Nevada, Oregon, and Washington state. There was no business in force in Wisconsin. American Star wrote commercial multi-peril, property, auto, liability, and surety business.

American Star filed a September 30, 1992, quarterly financial statement indicating capital and surplus of approximately \$5.5 million. A preliminary review of American Star's reserves for losses and loss adjustment expenses showed them to be deficient by about \$15.9 million, implying a negative net worth of about \$10.4 million. Furthermore, American Star had not obtained reinsurance coverage for policies it had written or renewed for December 1, 1992. Due to the foregoing factors, further transaction of business was hazardous to its policyholders and the general public, and American Star's owners consented to the liquidation.

Under the liquidation order, policies in force were terminated the earliest of: December 1, 1992, the date the policy expired, or the date new coverage was obtained by the agent. Certain guaranty funds extended the period of coverage for residents of their respective states, if such extension was required by law or administrative action. Ancillary liquidation proceedings were established in California, Idaho, Oregon, and New Mexico, and all have now been closed. The California ancillary liquidation proceeding was reopened on March 30, 2001, to allow a distribution of Proposition 103 rebates to California policyholders in the amount of \$1,750,000, but has since been closed. The Proposition 103 settlement was substantially below the \$10,362,838 reserved as of December 31, 1999.

At least 64,511 notices were mailed to agents, policyholders, state insurance commissioners, guaranty funds, claimants, former policyholders, and other parties whose interests may in some way be affected by the liquidation. The deadline for filing claims with the liquidator was November 16, 1993. Unexcused late filings will not be considered for payment.

On January 28, 1994, the liquidation court approved a plan to provide state guaranty funds with \$20,000,000 in early access payments to be used for the return of unexpired premiums to policyholders and payment of claims.

Early access payments were made during 1994 after each participating guaranty fund gave its written assent to the terms of the plan. Altogether the estate has advanced \$34,256,799.62 to participating guaranty funds under four early access agreements, of which \$29,403,159.43 has been converted into nonrefundable dividends.

The liquidation court has approved additional dividends, over and above the foregoing \$29,403,159.43, for full or partial payment of various class 1, 3, 4, 5, and 7 claims filed with state guaranty funds and directly with the estate, as recommended by the liquidator. Such additional dividends aggregated to \$11,051,238.17 as of December 31, 2000.

The liquidator has recommended partial payment or denial of certain class 1, 3, 5 and 8 claims filed directly with the estate. The liquidator reviews objections to partial payments or denials in the normal course of the run-off, and hearings are held before the liquidation court to adjudicate objections when necessary. In 2000, the liquidator resolved the last remaining claims listed in the first comprehensive Report on Claims filed with the liquidation court on December 9, 1997.

The second and comprehensive Report on Claims was filed on December 14, 1999. This report includes the liquidator's recommendations for full payment, partial payment, and denial on certain class 3, 5, and 7 claims. Pursuant to s. 645.65(1), Wis. Stat., the liquidator forwarded notice of recommendations for partial payment or denial to all affected claimants and advised them that they had 60 days to object to the recommendations. Three claimants objected. By the end of 2001, the liquidator resolved all but one of the remaining claims listed in the second comprehensive Report on Claims.

The third and most recent comprehensive Report on Claims was filed on March 27, 2002. This report includes the liquidator's recommendations for full payment, partial payment, and denial on certain class 5 and 8 claims. Once again the liquidator forwarded notice of recommendations for partial payment or denial to all affected claimants and advised them that they had 60 days to object to the recommendations. The liquidator will schedule hearings with respect to the claims of those claimants who file objections.

As of September 30, 2001, the estate reported assets of \$44,315,645. Claims in classes 1 through 10 were estimated at \$28,913,734, resulting in an estimated surplus of \$15,401,912.

Family Health Plan Cooperative, In Liquidation

Family Health Plan Cooperative was placed into liquidation on October 16, 2000. Matthew C. Mandt was appointed as special deputy liquidator.

Family Health Plan was headquartered in Brookfield, Wisconsin, and had business in force only in Wisconsin. Family Health Plan wrote health maintenance organization business and had just over 72,000 enrollees.

Under the liquidation order, policies in force were terminated the earliest of November 1, 2000, the date the policy expired, or the date new coverage was obtained by the enrollee. The liquidator assumed an Omnibus Agreement by and among Family Health Plan, Aurora Health Care (Aurora), United Wisconsin Services, Inc. (UWS), and Family Health Systems, Inc. The following provisions of the Omnibus Agreement approved by the court and the liquidator proceeded to:

- Transfer the assets of Family Health Plan to Aurora and/or UWS as set forth in the agreement;
- Transfer of certain liabilities to Aurora and UWS;

- Retention by the liquidator of certain designated excluded liabilities;
- Established claims procedures and other provisions of the agreement.

On October 31, 2000, 6,958 notices were mailed to creditors and other parties whose interests may in some way be affected by the liquidation. The deadline for filing claims with the liquidator was May 1, 2001.

Pre-liquidation claims for benefits under Family Health Plan policies, with the exception of Medicare select policies, were assumed by CompCare Health Services Insurance Corporation. Medicare select policies were assumed by Blue Cross Blue Shield United of Wisconsin. Virtually all these claims have been settled.

Forty-nine claims have been filed for liabilities not related to insurance policy benefits. These claims are currently under review to determine Family Health Plan's liability.

Master Plumbers' Limited Mutual Liability Company, In Rehabilitation

Master Plumbers' Limited Mutual Liability Company was placed in rehabilitation on March 29, 1994, by the Circuit Court for Dane County, Wisconsin. Matthew C. Mandt was appointed as Special Deputy Rehabilitator. Society Insurance, a Mutual Company, performs claim adjustment and administrative services for the rehabilitator pursuant to a contract approved by the court.

Master Plumbers' issued assessable policies and was licensed only in Wisconsin. The company wrote worker's compensation, other liability, and auto liability coverage for plumbers. All policies were written on an annual basis with January 1 effective dates.

In December 1993, pursuant to an order issued by the Commissioner, the company levied an assessment upon its policyholders equal to one additional annual premium. Collection of this assessment has been deferred until such future time as the funds may be needed. It has not been necessary to collect this assessment to date.

As of December 31, 2001, Master Plumbers' reports assets of \$1,294,337, liabilities of \$1,314,315 and a deficit of \$19,978. Liabilities include a provision of \$300,000 for 1993 and prior losses that may have occurred but have not yet been recorded.

Bureau of Market Regulation

The Bureau of Market Regulation (Bureau) consists of five sections: Complaints and Central Services, Accident and Health Insurance, Health and Life Insurance, Property and Casualty Insurance, and Agent Licensing. Agent licensing activities are described in a separate section.

The Bureau is responsible for the administration and enforcement of laws and rules relating to all market conduct activities of insurers and agents. In order to fulfill its duties the Bureau conducts targeted market conduct examinations of insurers in the areas of underwriting and rating; marketing, advertising and sales; claims; and policyholder services and grievances. The Bureau is also responsible for investigating and resolving approximately 10,000 written consumer complaints each year and answering 45,000 telephone inquiries. The Bureau also processes 2,000 rate and rule filings and approves 10,000 policy form filings each year.

During 2001, the Bureau was reorganized to better address the focus on market conduct analysis and more uniformity in the market conduct examination process. A new tool for organizing examination workpapers, TeamMate 2000, was introduced and will be used on all examinations. Two advanced examiner positions are dedicated full-time to the market conduct process. One position has an emphasis on data and serves as the expert on ACL, a software package used to sample data, and sampling. The second position will focus on quality control reviews and recommending and helping draft audit guides.

The Life and Health section was divided into two sections each reporting to a section chief. One section will address life insurance and some health insurance areas, the other section focuses exclusively on accident and health insurance. A new examiner position with job duties involving investigation of electronic commerce complaints was authorized and filled in late 2001. This position will monitor insurer and agent activity on the Internet and develop expertise in electronic commerce.

Among the major accomplishments in 2001 were:

- Made significant improvements in customer service by implementing a new complaint system including an imaging system to match correspondence electronically.
- Continuing to improve the market conduct examination program including allocating an

advanced examiner position whose duties were to develop and perform quality control reviews of examination workpapers; continuing to automate market conduct examination processes through the use of tools such as ACL and TeamMate 2000; and improving the examination process through the use of uniform data calls, audit guides, spreadsheets and report formats.

- In February 2001, became one of the first states to accept rate and form filings in all lines of insurance electronically through the System for Electronic Rate and Form Filing (SERFF).
- Successfully implemented a new system for tracking rates and forms and an imaging system to store electronic copies of approved forms and filed rates for easier public access.
- Successfully obtained a new position in the budget process to develop expertise in electronic commerce and to monitor insurer and agent activities, investigate consumer complaints and to carry out a workplan to monitor and develop policy on regulation and enforcement of insurance electronic commerce activities.
- Participated in promulgating rules on independent review organizations and grievances; Medicare supplemental and long-term care insurance; privacy; and producer licensing and continuing education.
- Significantly changed manual and system procedures for producer licensing, complaints, and rates and forms to conform to the requirements of COSMOS to update the procedures and systems to improve service and quality.
- Continued the urban outreach project by participating as liaison to the Insurance Services Committee of the Neighborhood Housing Services, providing staff to conduct training sessions for consumer groups in cooperation with the Community Insurance Information Center in Milwaukee and facilitated meetings between insurers and consumer groups.
- Participated in the Wisconsin Insurance Plan and the Wisconsin Automobile Insurance Plan meetings; quarterly meetings with the Worker's Compensation Rating Bureau and the Department of WorkForce Development; and provided technical assistance to the Small Employer Insurance Task Force.

- Served on the following NAIC committees, task forces and working groups: the System for Electronic Rate and Form Filing (SERFF) Working Group, Information for State-Based Systems subgroup, Speed to Market Working Group, Market Conduct Examination Oversight Task Force, the Producer Licensing Model Act Working Group, the Uniform Producer Licensing Working Group, the Senior Counseling Activities Working Group, the Life and Annuity Handbook Working Group, the Property and Casualty Examination Handbook Working Group and the SERFF Board of Directors.

Policy Form Submission

The following tables summarize the policy form submission data for 2000 and 2001. Table I shows the number of policy forms received in 2000 and 2001 by line of business for each type of insurance. Table II shows the number of policy forms received in 2001 by type of filing for each type of insurance. Table III shows the number of policy forms approved in 2000 and 2001 by line of business for each type of insurance.

Trends in Complaints

In 2001, there were an increased number of complaints involving illegal multiple employer welfare associations (MEWA), agent-related problems in sales to the elderly, the use of credit history in underwriting auto and homeowners insurance, claim handling related to storm damage and concerns about the rapidly increasing price of health insurance for individuals and small employers. The MEWA and agent complaints resulted in administrative actions.

The following tables summarize the bureau's complaint data. Table I shows a comparison of complaint activity over the last six years. A complaint is defined as a written expression of dissatisfaction with an insurance company or agent. Complaints may initially be received either in person, by telephone, by e-mail, or in writing. To be considered a formal complaint that initiates an inquiry or investigation, a complaint should be in writing. The data presented is based upon formal complaints.

In addition to the formal complaints, the Bureau also handled over 42,000 general inquiries or requests for information in 2001. Most such inquiries were by telephone, with the remainder being written communications, including e-mail, and "walk-ins."

Table II shows 2000 and 2001 complaints by type of insurance. When reviewing this information, it is important to note that a complaint may involve more than one type of insurance. Table III shows the area of insurance operations that generated the complaint. As with Table II, a complaint may involve more than one area of insurance operations.

Table III shows the basis for complaints. Over half the complaints involve claim problems. Policyholder service is the second most common reason for filing a complaint.

Agent Licensing Section

The Agent Licensing Section conducts licensing examinations for insurance agents; licenses agents, reinsurance intermediaries, managing general agents, certain corporations and firms, employee benefit plan administrators, viatical settlement brokers; and reviews and approves prelicensing and continuing education providers and courses.

During 2001, there were 9,245 tests administered in all lines of insurance to candidates seeking a resident agent license. In all, a total of 15,536 new licenses were issued to resident and nonresident agent candidates.

As of December 31, 2001, there were 78,406 licensed insurance agents and 614,541 active appointments by insurance companies authorizing the licensed agents to market their products.

Projects within the section for 2001 included:

- Successfully converted all agent data to a new computer database. COSMOS was purchased and implemented in October of 2001.
- Proposed changes to the administrative rules for agents to be reciprocal and more uniform under the Gramm-Leach-Bliley Act and the NAIC Producer Model.

- The fourth continuing education biennial reporting period for agents began January 1, 2001. Assessment Systems, Inc. (ASI), continues to administer the entire program, which includes provider, instructor, and course approval, as well as course tracking. To satisfy the biennial requirements, agents affected must earn 24 credit hours by February 15, 2003.
- Continued involvement with the NAIC in the development of a National Producer Database. The database will speed up and simplify the licensing process and provide benefits to both regulators and industry. Wisconsin participated as a pilot state for the project, and provides daily updates to the database along with 44 other states.
- Continued participation in the NAIC's Producer Information Network (PIN) Project. The goal of this committee, comprised of state regulators and industry representatives, is to improve the effectiveness and efficiency of the state licensing process through increased coordination, automation, standardization, and reciprocity.

Wisconsin is one of 40 states to sign a Declaration of Uniform Treatment through the NAIC. This Declaration provides for the use of a national application for major-line nonresident licensing.

Commercial Liability Insurance Reports
Section 601.422, Wis. Stat.

The following tables summarize the reports on commercial liability insurance required by s. 601.422, Wis. Stat., that were received in 2001. All of the information is for commercial liability insurance written in Wisconsin by authorized insurers. The data required by this statute were collected from the following three sources:

1. the insurers themselves,
2. statistical agents utilized by the insurers, and
3. the NAIC database.

Reporting thresholds were established by this office in conjunction with the statistical agents to eliminate insurers who write marginal amounts of insurance.

Tables IA and IB include information required for policy years 1998 and 1999, respectively. Lines one and two were calculated by applying the ratios of investment gain and other expenses to net premium earned for other liability as reported in the Insurance Expense Exhibit to direct premiums earned. The Insurance Expense Exhibit information is on a calendar year basis, therefore the ratios applied represent the average of the two calendar years included in the applicable policy year. The number of policies written, the number of claims closed without payment, and the number of legal actions filed were provided by the insurers. The remaining policy year information was provided by statistical agents.

It should be noted that the liability for claims incurred but not reported (IBNR) is calculated differently depending on the market. In particular, approximations for the IBNR liability for excess and umbrella insurance are based on the general liability expected loss ratio. The long-tailed nature of these two lines can create difficulty when attempting to establish an accurate liability for claims IBNR even after three or four years of development.

As noted previously, much of the data is from individual insurers and the statistical agents they utilize. These reports have been accepted by this office without audit.

Table II summarizes key ratios and averages for supplemental commercial liability data for the most recent five policy years. Several cells in this table are incomplete due to lack of activity for selected categories in certain policy years. Incomplete cells are indicated by an asterisk.

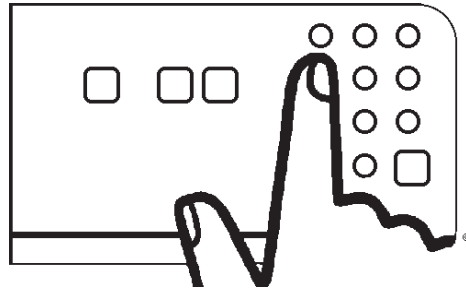

Notes to Tables

The financial information was obtained from the NAIC database downloaded on June 24, 2002, for those companies filing electronically with the NAIC and annual statements filed with OCI for those companies not filing electronically with the NAIC. The tables report the financial position of companies licensed to do business in Wisconsin as of December 31, 2001, and the results of their 2001 operations. Companies in rehabilitation and liquidation may not be included in the financial data.

All of the amounts in Tables F-I, except ratio amounts, have been rounded to thousands. Ratios in excess of "999" were reported as "999" and ratios less than "0" were reported as "0". Ratio results exceeding these thresholds are meaningless.

Premiums written in Table E includes insurers with negative premiums written. This resulted in premiums written for the 20 ranked insurers of credit life to be greater than all insurers writing credit life.

Limited Service Health Organizations and Hospital Medical Dental Indemnity Plans were combined in 2001 as Other Health Insurers.

The life annual statement changed in 2001 affecting direct premiums written and direct benefits paid. In 2000, deposit funds were included with direct life premiums written to be consistent with direct life benefits paid. In 2001 deposit funds were no longer included with direct life premiums written. Other considerations were included in annuity premiums in 2001. Surrender values and write-in benefits were included with annuity benefits (if there was annuity premium) to be consistent with direct premiums in Table D. Other considerations were not included in annuities in Table E.

For Life and Health insurers filing on the new Health blank, direct premiums earned were used to report direct premiums written. For most companies, there was no significant difference between the amounts.

Explanation of Terms Used in Tables

The “*Wisconsin Operations*” columns report the direct premiums and losses for Wisconsin only business for 2001. The “*Nationwide Operations*” columns report the net premiums and losses for all operations for 2001.

“*Direct*” business refers to business which the insurer issued an insurance policy and accepted the premium. “*Net*” business is direct business plus reinsurance assumed and less reinsurance ceded.

“*Reinsurance*” is the transfer of risk between insurance companies. Almost all direct writing companies use reinsurance to transfer risk. Reinsurance assumed is accepting the risk of other insurers, while reinsurance ceded is transferring the risk to other insurers. Some companies specialize in providing reinsurance to other companies versus writing business directly.

“*Premium Written*” is usually defined as premium billed by fire and casualty companies. Rules of life insurance accounting require reporting premiums actually collected. Premium written is a measure of sales activity in the state for the year.

“*Premium Earned*” is the result of premiums written in the current and previous years, and in some instances, premiums to be written in the future for current coverages. It is approximately the pro-rata portion of the premium charged for each policy for the portion of coverage provided within the calendar year.

“*Losses Incurred*” equals losses paid, plus an estimate at the close of the current year of the amounts to be paid in the future for all unsettled claims as of the financial statement date, less the corresponding estimate made at the end of the prior year. If the estimates were exactly correct, then the incurred losses would be the

actual cost of all claims arising from coverage provided during the current year. The estimates would also include amounts for IBNR claims (incurred but not reported). Loss adjustment expenses are also included in the losses incurred for nationwide operations of Title Companies.

“*Annuity Considerations*” is revenue received for annuity contracts during the year. The amount corresponds to premiums written on insurance contracts.

“*Other Considerations*” are annuity considerations or other deposits, which are not allocated to a specific policy, but include an insurable risk.

The “*Net Loss Ratio*” is equal to net losses incurred plus net loss adjustment expenses incurred, divided by net premiums earned. The “*Expense Ratio*” is equal to underwriting expenses divided by net premiums written. The loss ratio is determined based on net premiums earned as losses occur randomly throughout the policy term which matches the period the premiums are earned. The expense ratio is determined using net premiums written, because most underwriting expenses (commissions, home office underwriting, and clerical expenses) are incurred at the time the policy is written, not evenly throughout the policy term.

The “*Wisconsin Direct Loss Ratio*” is a pure loss ratio equal to the direct losses incurred divided by the direct premiums earned for Wisconsin business. This ratio does not include Loss Adjustment Expenses. For insurers with small direct premiums earned, this ratio may not be a meaningful representation of their overall operations. Negative losses incurred would result from the company overestimating the cost to settle open claims as of the end of the prior year or the receipt of salvage or other recoveries from claims paid in prior years which were in excess of amounts incurred for the current year claims.

Directory of Licensed Insurers

This directory includes all companies, fraternal benefit societies, associations, and town mutuals licensed or otherwise authorized to transact the business of insurance in this state as of December 31, 2001. (For current

information, see OCI's Web site at http://oci.wi.gov/dir_ins.htm.) The codes used to designate the kind of company and a brief description of each follows.

BP—Blue Plan. A domestic insurance corporation incorporated under ch. 611 or ch. 613, Wis. Stat. Blue plans offer health insurance to individual or group subscribers on an indemnity basis, or offer services through an embedded health maintenance organization using contracted service providers. Blue plans file the NAIC Health annual statement blank.

CC—Continuing Care Organization. Organized under ch. 647, Wis. Stat. Continuing care organizations provide nursing, medical, or personal care services, and maintenance services, for a period over one year or the duration of a person's life, conditioned upon payment of an entrance fee or a portion of the person's estate. Continuing care organizations file a financial statement, on a GAAP basis, which is audited by an independent CPA.

DP—Dental Plan. Similar to a blue plan, except that indemnity or services are limited to dental services.

FC—Fire and Casualty Company. A domestic insurer organized and operating under ch. 611, Wis. Stat., or a nondomestic insurer licensed under ch. 618, Wis. Stat., and may be a mutual or stock company. Fire and casualty companies write a wide range of property and liability coverages, and individual and group health insurance. Fire and casualty companies file the NAIC Fire and Casualty annual statement blank.

FR—Fraternal Benefit Society (or Mutual Benefit Society). May be a domestic benefit society organized and operating under ch. 614, Wis. Stat., or a nondomestic benefit society operating under ch. 618, Wis. Stat. A fraternal benefit society is a nonstock corporation which exists for social, educational, charitable, or religious purposes, and also may sell individual life or health insurance to its members. A fraternal is governed through a lodge system and a representative form of government, and members voluntarily perform charitable, educational, etc. services for other members or the public. Fraternal benefit societies file the NAIC Fraternal Orders annual statement blank.

GA—Gift Annuity Corporation. Established by a domestic or foreign nonprofit corporation under ch. 615, Wis. Stat. Gift annuities receive gifts of money or property, in return for agreeing to pay an annuity to the donor. Remaining income may be transferred to the nonprofit corporation for its charitable, religious, etc. purposes. Gift annuities file the NAIC Charitable Annuity Corporations annual statement blank.

HM—Health Maintenance Organization (HMO). Established under chs. 185, 611, 613, or 618, Wis. Stat., and operates under ch. 609, Wis. Stat. HMOs may be for profit, nonprofit, or a cooperative. An HMO makes available comprehensive health care services (performed by providers contracted by the HMO) to enrolled participants for predetermined fixed payments. An HMO may hire medical service providers as employees, or may contract with existing hospitals and clinics to provide services to participants. HMOs file the NAIC Health annual statement blank.

LC—Life and Accident and Health Company. May be a domestic insurer organized and operating under ch. 611, Wis. Stat., or a nondomestic insurer licensed under ch. 618, Wis. Stat., and may be a mutual company or a stock company. Life and accident and health companies write a wide range of life, annuity, individual, and group health insurance. Life and accident and health companies file either the NAIC Life and Accident and Health annual statement blank or the NAIC Health annual statement blank.

LH—Limited Service Health Organization (LSHO). Similar to an HMO, except that it provides a limited range of health care services (such as vision or dental) to participants. LSHOs file the NAIC Health annual statement blank.

MC—Motor Club Plan. Established under ch. 616, Wis. Stat. A motor club plan may provide emergency road service, towing, bail bonds, map and touring service, etc. to members. Motor club plans file a financial statement which has been audited by an independent CPA.

MX—Miscellaneous Other Insurer.

RE—Reciprocal Exchange. A nondomestic insurer licensed under ch. 618, Wis. Stat. Reciprocals are unincorporated associations, operating through an attorney-in-fact, by which subscribers with similar interests (e.g., lumberyards, dry cleaners) provide fire and casualty insurance to each other through the exchange of insurance contracts. Reciprocals file the NAIC Fire and Casualty annual statement blank.

TC—Title Company. May be a domestic insurer organized and operating under ch. 611, Wis. Stat., or a nondomestic insurer operating under ch. 618, Wis. Stat. Title companies notify a prospective purchaser of recorded liens or easements on a parcel of real estate, and provide insurance against loss due to other defects in title to property (e.g., due to forgery, fraud, errors in public records, wills not probated, etc.). Title companies file the NAIC Title Insurance annual statement blank.

TM—Town Mutual of Wisconsin. A domestic fire and casualty insurer subject to ch. 612, Wis. Stat., as an assessable mutual. Town mutuals are authorized to write a limited range of property and liability coverage, in a limited number of counties in Wisconsin. Town mutuals may file either the NAIC Fire and Casualty annual statement blank or the Wisconsin Town Mutual annual statement blank.

VP—Vision Plan. Similar to a blue plan, except that indemnity or services provided are limited to eye care services.

WP—Warranty Plan. Established under ch. Ins 15, Wis. Adm. Code. A warranty plan is a third party which provides repair, replacement, or maintenance services in connection with the sale of goods from seller to buyer (e.g., automobiles, homes, appliances, etc.). (Warranties by the seller, manufacturer, or provider of service directly to the buyer are exempted from regulation by this office.) Warranty plans file audited GAAP based financial statements with this office.
