May 29, 2020 Bulletin Rescission

Since OCI's May 29, 2020 bulletin allowing providers to present courses via webinar on a temporary basis, over 450 CE courses 24 prelicensing courses have temporarily been converted to webinars.

OCI will be lifting the use of temporary webinars effective **July 1, 2021**. Providers will be expected to file new webinar courses and have them approved prior to this date if you wish to continue to use the temporary classroom courses in a webinar setting.

OCI will also be lifting the use of the Personal Attestation Form for students effective **July 1, 2021**. Providers should ensure proper notification is given to their students.

UPDATES AND REMINDERS

Annuity Best Interest Training: within six months after OCI's effective date, a producer who has already completed the existing annuity suitability required training must either take a four-credit training course or an additional on-time credit training course.

Pharmacy Benefit Plan Administrator Licensing: required to be effective January 1, 2022.
