RE: Form A Statement Regarding the Proposed Acquisition o Control of Badger Mutual Insurance Company

Dear Commissioner Houdek:

On behalf of Rural Mutual Insurance Company, a Wisconsin domestic mutual insurance corporation organized under Chapter 611 of the Wisconsin Statutes ("<u>Rural</u>"), enclosed please find a Form A Statement Regarding the Acquisition of Control of a Domestic Insurer (the "<u>Form A</u>") seeking the approval of the Commissioner of Insurance of the State of Wisconsin (the "<u>Commissioner</u>") pursuant to Wis. Stat. § 611.72(2) and Wis. Admin. Code § Ins 40.02 for the proposed acquisition of control of Badger Mutual Insurance Company ("<u>Badger</u>") through an affiliation of the two companies (the "<u>Proposed Affiliation</u>"). The Proposed Affiliation will occur pursuant the Affiliation Agreement, by and between Rural and Badger, dated September 25, 2024 (the "<u>Affiliation</u>").

Effective on January 1, 2025, the anticipated effective date of the Proposed Affiliation (the "<u>Anticipated Effective Date</u>"), if all closing conditions required by the Affiliation Agreement have been satisfied or waived, Badger will affiliate with Rural as described in the Form A.

To effectuate the Proposed Affiliation, Rural and Badger will enter into a management agreement (the "<u>Management Agreement</u>"). Additionally, Rural and Badger will enter into a reinsurance agreement (the "<u>Reinsurance Agreement</u>"). Each of these unexecuted agreements are included as exhibits to the Affiliation Agreement. The companies will also file the Reinsurance Agreement and the Management Agreement in one or more Form D filings as required under Wis. Adm. Code § Ins 40.04.
