



Corewell Health - Corporate Structure

- 1 "Corewell Health Gerber Hospital" is an assumed name or "d/b/a". The legal name of the corporation is "Newaygo County General Hospital Association".
- 2 "Corewell Health Ludington Hospital" is an assumed name or "d/b/a". The legal name of the corporation is "Memorial Medical Center of West Michigan".
- 3 "Corewell Health Big Rapids Hospital" is an assumed name or "d/b/a". The legal name of the corporation is "Macosta County Medical Center".
- 4 "Corewell Health Reed City Hospital" is an assumed name or "d/b/a". The legal name of the corporation is "Reed City Hospital Corporation".
- 5 "Corewell Health Penook Hospital" is an assumed name or "d/b/a". The legal name of the corporation is "Penook Hospital".
- 6 "Corewell Health Zeeland Hospital" is an assumed name or "d/b/a". The legal name of the corporation is "Zeeland Community Hospital".
- 7 "Corewell Health Medical Group West" is an assumed name or "d/b/a". The legal name of the corporation is "Spectrum Health Primary Care Partners".
- 8 "Lakeshore Area Radiation Oncology Center" is owned 41.2% by "Corewell Health Grand Rapids Hospitals" and 17.6% by "Corewell Health Zeeland Hospital". Corewell Health's collective ownership is 58.8%.
- 9 "Lemmon-Holton Cancer Pavilion Condominium Association" is owned by Corewell Health Hospitals (40.57%), however "Corewell Health Grand Rapids Hospitals" has 82.98% of the voting rights. Additionally, "Corewell Health Medical Group West" has 3.72% ownership.
- 10 Various Corewell Health entities have ownership in "West Michigan Shared Hospital Laundry", and in aggregate Corewell Health's ownership is 41.2% with a total of 14 of 34 votes.
- 11 Various Corewell Health entities have ownership in "Western Michigan Associates", and in aggregate Corewell Health's ownership is 41.2% with a total of 14 of 34 votes.
- 12 "Select Specialty Hospital - Corewell Health Grand Rapids" is an assumed name or "d/b/a". The legal name of the corporation is "Special Care Hospital, LLC".
- 13 Michigan Street Project Condominium Association is owned by 5 condo associations 20% each: Lemmon-Holton Cancer Pavilion Condominium Association, 35 Michigan Street Condominium Association, 25 Michigan Street Condominium Association, The Michigan Street Parking Condominium Association, Board of Trustees of Michigan State University.
- 14 "Corewell Health South" is an assumed name or "d/b/a". The legal name of the corporation is "Lakeland Regional Health System".
- 15 "Caring Circle" is an assumed name or "d/b/a". The legal name of the corporation is "Hospital at Home, Inc".
- 16 "Corewell Health Rehabilitation & Nursing Center - Pine Ridge" is an assumed name or "d/b/a". The legal name of the corporation is "Mercy-Memorial Health Services, Incorporated".
- 17 Corewell Health owns 50 of 51 units in West Michigan Accountable Care Organization, LLC.
- 18 "Corewell Health Rehabilitation & Nursing Center - Commons Dearborn" is an assumed name or "d/b/a". The legal name of the corporation is "Oakwood Health Promotions, Inc".
- 19 "Penook Endoscopy" is an assumed name or "d/b/a". The legal name of the corporation is "Penook Ventures, Inc".
- 20 Corewell Health Grand Rapids Hospitals has 6.2% ownership interest in 35 Michigan Street Condominium Association. However, Corewell Health Grand Rapids Hospitals has 100% of the voting rights.
- 21 "Corewell Health Lakeland Hospital" is an assumed name or "d/b/a". The legal name of the corporation is "Lakeland Hospitals at Niles and St. Joseph, Inc".
- 22 "Corewell Health Watervliet Hospital" is an assumed name or "d/b/a". The legal name of the corporation is "Lakeland Community Hospital, Watervliet".
- 23 "Corewell Health Southwest Michigan" is an assumed name or "d/b/a". The legal name of the corporation is "Lakeland Health Foundation, Benton Harbor/St. Joseph".
- 24 "Corewell Health Medical Group South" is an assumed name or "d/b/a". The legal name of the corporation is "Lakeland Medical Practices".
- 25 "Corewell Health Indemnity Company, Ltd." is the new legal name for the entity formerly known as "Beaumont Indemnity Company, Ltd".
- 26 "Corewell Health William Beaumont University Hospital" is an assumed name or "d/b/a". The legal name of the corporation is "William Beaumont Hospital".
- 27 "Corewell Health Farmington Hills" is an assumed name or "d/b/a". The legal name of the corporation is "Botsford General Hospital".

- 41 "Corewell Health Medical Group East - Specialty Services" is an assumed name or "d/b/a". The legal name of the corporation is "Beaumont Medical Group - Specialty Services".
- 42 "Atrium CMC" is an assumed name of "d/b/a". The legal name of the corporation is "Oakwood Accountable Care Organization, LLC".
- 43 Subsidiaries of Corewell Atlas IV LLC have a planned 51% LLC / 49% physicians ownership when they become syndicated. Ownership will be 100% owned by the LLC until syndication takes place.
- 44 Oakwood Affiliated Ventures, Inc. held a 50% ownership stake in Beaumont Urgent Care by Wellstreet until July 1, 2024, when it acquired full 100% ownership. Subsequently, Beaumont Urgent Care by Wellstreet legally changed its name to Corewell Health Urgent Care, LLC. Corewell Health Urgent Care, LLC also manages WellStreet Urgent Care of Michigan, P.C. d/b/a Corewell Health Urgent Care, but does not hold any ownership in it.
