

**REPORT OF SPECIAL MEETING OF THE MEMBERS
FOR THE PURPOSE OF VOTING ON THE CONVERSION OF
SENECA, SIGEL MUTUAL INSURANCE COMPANY
WITH AND INTO
LEBANON-CLYMAN MUTUAL INSURANCE COMPANY**

November 9, 2024

Lebanon-Clyman Mutual Insurance Company ("Lebanon"), hereby submits to the Office of the Commissioner of Insurance (the "OCI") pursuant to Wis. Stat. § 612.23(5) this report of the Special Meeting of Members held on November 9, 2024, at 1:30 PM at the Lebanon Fire Department at N178 County Road R, in Lebanon, Wisconsin (the "Special Meeting") to discuss and to vote on the proposed the proposed conversion of Seneca, Sigel Mutual Insurance Company ("Seneca") with Lebanon into a single mutual insurance corporation under Chapter 611 (the "Conversion").

On October 8, 2024, the members of Lebanon were mailed (i) a Notice of the Special Meeting in the form attached hereto as Exhibit A (the "Member Notice"), and (ii) a summary of the Agreement and Plan of Conversion between Seneca and Lebanon (which was approved by the Board of Directors of Lebanon on August 12, 2024, and by the OCI on November 6, 2024), and (iii) a policyholder resolution ballot for members to vote on the resolution authorizing the Conversion by mail (the "Mail Ballot") (collectively, the "Conversion Materials"). The Member Notice instructed the members to review the Conversion Materials and attend the Special Meeting to vote on the Conversion in person or by mail.

At the Special Meeting, after the members of Lebanon reviewed the previously disseminated Conversion Materials and had the opportunity to ask questions of the respective designated representatives of Lebanon relating to the Conversion, the following resolution was adopted by the members of Lebanon:


RESOLVED, that after review of the Summary of the Plan of Conversion and the Agreement and Plan of Conversion (collectively, the "Conversion Documents"), and the ability to inquire of the Board of Directors regarding the same, the members of Seneca hereby (i) adopt and approve the Agreement and Plan of Conversion substantially in the form made available to the members, including the articles of incorporation and bylaws and election of the proposed directors of the Board of Directors of the Converted Corporation as set forth in the Conversion Documents, and (ii) authorize its Board of Directors to take any remaining actions necessary to effectuate the Conversion..

1,798 members of Lebanon were entitled to vote at the Special Meeting. Of the 267 members of Lebanon who voted on the resolution, 258 voted in favor of adoption and 9 members voted against adoption. Of the members voting in person, 9 voted in favor of adoption and 0 members voted against adoption. Of the members voting by Mail Ballot, 249 voted in favor of adoption and 9 voted against adoption.

RESOLVED, that after review of the Summary of the Plan of Conversion and the Agreement and Plan of Conversion (collectively, the “Conversion Documents”), and the ability to inquire of the Board of Directors regarding the same, the members of Lebanon hereby (i) adopt and approve the Agreement and Plan of Conversion substantially in the form made available to the members, including the articles of incorporation and bylaws and election of the proposed directors of the Board of Directors of the Converted Corporation as set forth in the Conversion Documents, and (ii) authorize its Board of Directors to take any remaining actions necessary to effectuate the Conversion.

The Board of Directors of Lebanon recommends that you vote “YES” on the policyholder resolution to approve the Agreement and Plan of Conversion. Members will also consider and vote upon any matters as may properly come before the meeting or any adjournments or postponements thereof.

All Lebanon policyholders have a right to vote on the Conversion under Wis. Stat. § 612.12. Policyholders may cast their vote in person at the special meeting or by completing and returning the enclosed Policyholder Resolution Ballot.

Enclosed with this correspondence is a Summary of the Plan of Conversion and Policyholder Resolution Ballot. **Please review these materials and return this ballot as instructed below by 5:00 PM on November 8, 2024.**

The Agreement and Plan of Conversion was filed by both companies with the Office of the Commissioner of Insurance on September 9, 2024. Pursuant to Wisconsin law, the parties must obtain the Commissioner’s approval of the Agreement and Plan of Conversion prior to it being submitted to a vote of the policyholders.
