I am pleased to report that both Seller and American Family are now in agreement with the proposed approach to redaction that you suggested and we discussed in our calls on Wednesday on the subject, without further need of additional redaction requests on our end. Namely, we will not seek redaction of the "Survival; Indemnification" line in the Table of Contents.
