Further to Lisa's e-mail, a version reflecting both Quartz's and my comments is currently with Advocate Aurora for review. Ruhee Divgi, the responsible attorney, is out of the office today but I hope to have a final version on Monday (and in any case early next week).

Advocate Aurora will be executing its waiver on its own behalf – as soon as we are clear which executives will be signing, I'll share a draft as well.
