Bellin Gundersen Health System, Inc. Corporate Members

Set forth below is a summary of the key provisions outlined in the bylaws ("<u>Bylaws</u>") of Bellin Gundersen Health System, Inc. ("<u>BGHS</u>") with respect to its members.

a. Function, Role, and Oversight Responsibilities

The BGHS members' role is to guide the holistic direction of the company by exercising its rights set forth in the BGHS Bylaws and Chapter 181 of the Wisconsin Statutes (the "Act").

The BGHS Bylaws provide generally that the members may vote on all matters submitted to a vote of the members and all other rights and powers as set forth in the BGHS Bylaws and the Act. For example, pursuant to the BGHS Bylaws, the members may appoint additional members and elect directors. Additional statutory rights which may be conferred upon members of nonstock corporations are further detailed in the Act.

b. Member Selection

Members must have a primary residence in either (a) certain counties generally in the Bellin Health Systems, Inc. ("Bellin") service area, which counties are set forth in the BGHS Bylaws (such members designated as "Northern Counties Members"), or (b) certain counties generally in the Gundersen Lutheran Health System, Inc. ("Gundersen") service area, which counties are set forth in the BGHS Bylaws (such members designated as "Southern Counties Members"). The entirety of, and each class of, the initial BGHS members consist of equal numbers of Northern Counties Members and Southern Counties Members. The initial BGHS members are intended to equally represent each of Gundersen and Bellin's service areas. The BGHS Bylaws require that the members shall endeavor at all times to ensure there is an even number of Northern Counties Members and Southern Counties Members.

If an initial member resigns, is removed, or ceases to be a member during their initial term, the remaining Northern Counties Members may appoint a replacement if the resigned or removed member was a Northern Counties Member. Similarly, the remaining Southern Counties Members may appoint a replacement if the resigned or removed member was a Southern Counties Member. After the initial term, the replacement for any resigned or removed member may be appointed by a majority of all of the remaining members. After members' terms expire, they may be reappointed for subsequent terms.
