Re: Merger of All-Star/Newark Mutual Insurance Company with and into Franklin Farmers Mutual Insurance Company

Dear Commissioner Houdek:

The Boards of Directors of All-Star/Newark Mutual Insurance Company, a Wisconsin town mutual insurance corporation ("<u>ASNMIC</u>") and Franklin Farmers Mutual Insurance Company, a Wisconsin town mutual insurance corporation ("<u>FFMIC</u>", together with ASNMIC are collectively referred to herein as the "<u>Constituent Corporations</u>" and each a "<u>Constituent Corporation</u>"), have approved the merger of ASNMIC with and into FFMIC (the "<u>Merger</u>"). Pursuant to Wis. Stat. § 612.21, we are submitting for your review the documents and exhibits set forth below, and respectfully request your approval of the Merger. Please note, FFMIC will be the surviving corporation, but will be adopting the name Riverside Mutual Insurance Company ("<u>Riverside</u>") on January 1, 2024, the proposed effective date of the Merger.
