#### Dear Commissioner Houdek:

The Boards of Directors of Heartland Mutual Insurance Company, a Wisconsin town mutual insurance corporation ("<u>Heartland</u>") and Arlington Mutual Insurance Company, a Wisconsin town mutual insurance corporation ("<u>Arlington</u>"), have approved the merger of Heartland with and into Arlington (the "<u>Merger</u>").
