River Valley Mutual Insurance Company ("RVMIC"), hereby submits to the Office of the Commissioner of Insurance (the "OCI") pursuant to Wis. Stat. § 612.23(5) this report of the emergency Special Meeting of Members held on December 12, 2023, at 10:00 a.m. at the Whitehall Golf & Pub, 36535 West Street, Whitehall, Wisconsin (the "Special Meeting") to discuss and to vote on the proposed merger (the "Merger") of Henrietta, Greenwood & Union Mutual Fire Insurance Company ("Henrietta") with and into RVMIC.
On November [], 2023, the members of RVMIC were mailed (i) the Notice of the Special Meeting in the form attached hereto as Exhibit A (the "Member Notice") and (ii) a summary of the Agreement and Plan of Merger between RVMIC and Henrietta (which was approved by the Board of Directors of RVMIC on November 20, 2023 and by the OCI on November [], 2023) (collectively, the "Merger Materials"). <b>RESOLVED</b> , that after review of the Summary of the Agreement and Plan of Merger and/or the Agreement and Plan of Merger (collectively, the "Merger Documents"), and the ability to inquire of the Board of Directors of RVMIC regarding the same, the members of RVMIC hereby adopt and approve, in all material respects, the Merger pursuant to the Agreement and Plan of Merger substantially in the form made available to the members and authorize its Board of Directors to take any and all remaining actions necessary to effectuate the Merger.
