Re: Merger of Riverside Mutual Insurance Company with and into Central Wisconsin Mutual Insurance Company

#### Dear Commissioner Houdek:

The Boards of Directors of Riverside Mutual Insurance Company, a Wisconsin town mutual insurance corporation ("<u>Riverside</u>"), and Central Wisconsin Mutual Insurance Company, a Wisconsin mutual insurance corporation ("<u>Central Wisconsin</u>"), have approved the merger of Riverside with and into Central Wisconsin (the "<u>Merger</u>"). Pursuant to Wis. Stat. § 612.22, we are submitting for your review the documents and exhibits set forth below, and respectfully request your approval of the Merger.

- 6. The following Central Wisconsin-related documents:
  - (a) The most recent year-end annual statement for Central Wisconsin.
  - (b) The most recent quarterly statement for Central Wisconsin.

Please note, Riverside has tentatively scheduled an emergency special meeting for its policyholders on October 4, 2025. Accordingly, Riverside hopes to be able to complete the mailing by September 3, 2025, and respectfully requests that you provide preliminary approval for the policyholder mailings to be sent by the date. Please let us know if you have any concerns with this proposed timeline.
