Spring Grove Mutual Insurance Company ("<u>SGMIC</u>") submits to the Office of the Commissioner of Insurance (the "<u>OCI</u>") pursuant to Wis. Stat. § 612.21(6) this report of the Special Meeting of Members held on [●], 2023 at [●] p.m. at [●], Wisconsin to discuss and to vote on the proposed merger of SGMIC with and into La Prairie Mutual Insurance Company ("<u>LPMIC</u>") (the "<u>Special Meeting</u>").

**RESOLVED**, that after review of the Summary of the Plan of Merger and/or the Agreement and Plan of Merger with respect to the merger of SGMIC with and into LPMIC, and the ability to inquire of the Board of Directors of SGMIC regarding the same, the members of SGMIC hereby adopt and approve the Merger pursuant to the Agreement and Plan of Merger substantially in the form made available to the members and authorize its Board of Directors to take any remaining actions necessary to effectuate such merger.
