

How to Verify Your Employer Affiliation in the IPFCF System

If your employer or a group administrator is responsible for paying for your Injured Patients & Families Compensation Fund (IPFCF or the “Fund”) Annual Assessment, then you will want to verify if you are affiliated with your employer’s IPFCF group account.


You can verify this information two different ways.

Option 1:

Log onto your personal IPFCF Provider Portal Account here:

<https://ipfcfsecure.oci.wi.gov/>

From the Home Page select the **Affiliations** button at the top of the screen.



On the Affiliations screen you will see your current employer or group if you are linked to their account, and you can see your past two employers or groups if applicable.

If you are currently affiliated with your employer or group’s IPFCF account, you will see them displayed with an effective date only. If there is an expiration date displayed, you are not affiliated with that employer or group any longer.

Option 2:

Access your public IPFCF records from the IPFCF Public Provider Database Search here: <https://ipfcfportal.oci.wi.gov/>

Type your name or Wisconsin license number into the search bar and select the magnifying glass icon. The search results will populate below the search bar. Select your name to access your public records.
