Top Conditions/Rx Drug data collection OCI made a few small adjustments to the PY 2021 templates when preparing the templates for PY 2022. For example, a column was added to reflect the percent of WIHSP claims the conditions are reflecting. A copy of the PY 2022 template was sent along with this report.					
PY 2024 Payment Parameters OCI met with its contracted actuary, Wakely, to finalize a work plan for establishing the PY 2024 payment parameters. State law requires parameters to be established by May 15th (or a date established by the Commissioner). This year, the date may extend a bit past May 15th to align with federal EDGE data submission deadlines. A data call was sent to insurers to collect enrollment and claims data, which will be used to inform the					
payment parameters. OCI discussed preliminary results of that data call on March 15th.					
Governor's 2023-2025 Budget Bill The Governor has proposed increasing the WIHSP spending cap each year based on the consumer price					

index for medical care spending beginning January 2024, to affect 2025 WIHSP payments . He also proposed a new position within OCI to administer the program. The Legislature will work on the budget for the next several months. It is not known at this time whether the Governor's WIHSP proposals will be included in the final budget. OCI will monitor the budget's progress and report an update in the next quarterly report.
