## Dear Commissioner Afable:

Enclosed with this letter pursuant to Chapter 611 of the Wisconsin Statutes, Chapter Ins 40, Wis. Admin Code, and Chapter Ins 57, Wis. Admin Code is the Form A Statement ("Form A") regarding the acquisition of control by My Choice Foundation Holdings Inc., a Wisconsin nonstock corporation ("MCFH" or "Applicant") of the parent company of My Choice Wisconsin Health Plan Inc., a nonstock insurance corporation ("MCWHP" or "Domestic Insurer"), My Choice Wisconsin Inc., a Wisconsin nonstock corporation ("MCW' or "Care Management Organization").

Included with this filing are electronic copies of the Form A and required exhibits. We are filing under separate cover the exhibits and information for which the Applicant, Domestic Insurer and Care Management Organization are seeking confidential treatment pursuant to Wis. Stat. §§ 134.90, 601.42, 601.465 and Wis. Admin. Code Ins. § 40.05. The Applicant and Domestic Insurer request confidential treatment of the Biographical Affidavits and Financial Projections, as those exhibits and information contain confidential information that could put MCFH, MCWHP and MCW at a competitive disadvantage if it were to become known to the public. The Applicant, Domestic Insurer and Care Management Organization take reasonable efforts to keep this information confidential. Accordingly, the information constitutes a "trade secret" under Wis. Stat. § 134.90(1)(c) because it "derives independent economic value, actual or potential, from not being generally known to, and not being readily ascertainable by proper means by, other persons who can obtain economic value from its disclosure or use [and] is the subject of efforts to maintain its secrecy that are reasonable under the circumstances." Under Wis. Stat. § 19.36(5) and Wis. Admin. Code Ins 6.13(2), a trade secret is exempt from the public records law. Therefore, the Applicant requests that OCI maintain the confidentiality of this information and not release this information to the public.
