Dear Ms. Malm:

On behalf of Liberty Mutual Holding Company Inc. ("<u>LMHC</u>"), LMHC Massachusetts Holdings Inc. and Liberty Mutual Group Inc. (collectively, the "<u>Applicants</u>"), we submitted a Form A Statement, dated August 5, 2021 (the "<u>Form A</u>"), relating to the proposed acquisition of control of State Auto Insurance Company of Wisconsin, a property and casualty insurance company domiciled in Wisconsin (the "<u>Domestic Insurer</u>"), by the Applicants.
