REPORT OF SPECIAL MEETING OF THE MEMBERS FOR THE PURPOSE OF VOTING ON THE MERGER OF ALL-STAR/NEWARK MUTUAL INSURANCE COMPANY WITH AND INTO FRANKLIN FARMERS MUTUAL INSURANCE COMPANY

NOVEMBER 11, 2023

All-Star/Newark Mutual Insurance Company ("<u>ASNMIC</u>") submits to the Office of the Commissioner of Insurance (the "<u>OCI</u>") pursuant to Wis. Stat. § 612.21(6) this report of the Special Meeting of Members held on November 11, 2023, at 10:00 a.m. at the Spring Green Community Center, Spring Green, Wisconsin to discuss and to vote on the proposed merger of ASNMIC with and into Franklin Farmers Mutual Insurance Company ("<u>FFMIC</u>") (the "<u>Special Meeting</u>").

On October 12, 2023, the members of ASNMIC were mailed (i) the Notice of the Special Meeting in the form attached hereto as Exhibit A (the "Member Notice"), (ii) a summary of the Plan of Merger between ASNMIC and FFMIC (which was approved by the Board of Directors of ASNMIC on August 31 2023 and by the OCI on October 9, 2023), and (iii) a policyholder resolution ballot for members to vote on the resolution authorizing the merger by mail (the "Mail Ballot"), (collectively, the "Merger Materials"). The Member Notice instructed the members to review the Merger materials and return their Policyholder Resolution Ballot to the address provided in the Member Notice by 10:00 a.m. on November 11, 2023, or to appear at the Special Meeting and vote in person.

At the Special Meeting, after the members of ASNMIC reviewed the previously disseminated Merger Materials and had the opportunity to ask questions of the respective designated representatives of ASNMIC and FFMIC relating to the Merger, the following resolution was adopted by the members of ASNMIC:

RESOLVED, that after review of the Summary of the Plan of Merger and/or the Agreement and Plan of Merger of ASNMIC with and into FFMIC, and the ability to inquire of the Board of Directors regarding the same, the members of ASNMIC hereby adopt and approve in all material respects the Merger pursuant to the Agreement and Plan of Merger and authorize its Board of Directors to take any remaining actions necessary to effectuate such merger.

2101 members of ASNMIC were entitled to vote at the Special Meeting. Of the 169 members of ASNMIC who voted on the resolution, 166 voted in favor of adoption and 3 members voted against adoption. Of the members voting in person, 7 voted in favor of adoption and 1 member voted against adoption. Of the members voting by Mail Ballot, 159 voted in favor of adoption and 2 members voted against adoption.
